L-1		For the entire facility, the permittee shall not cause, allow, or permit the discharge into the ambient air from any point source or emissions, any air contaminant of such opacity to obscure an observer's view to a degree in excess of 40%, as determined by EPA Test Method 9, 40 CFR Part 60, Appendix A. This shall not apply to vision obscuration caused by uncombined water droplets. Startup operations may produce emissions which exceed 40% opacity for up to fifteen (15) minutes per startup in any one hour and not to exceed three (3) startups per stack in any twenty-four (24) hour period. L-2		Except as otherwise specified, no person shall cause, permit, or allow the emission of particulate matter in total quantities in any one hour from any manufacturing process, which includes any associated stacks, vents, outlets, or combination thereof, to exceed the amount determined by the relationship $E = 4.1 * p^0.67$, where E is the emission rate in pounds per hour and p is the process weight input in tons per hour. - (i) an emergency occurred and that the permittee can identify the cause(s) of the emergency;
- (ii) the permitted facility was at the time being properly operated;
- (iii) during the period of the emergency the permittee took all reasonable steps to minimize levels of emissions that exceeded the emission standards, or other requirements in the permit; and
- (iv) the permittee submitted notice of the emergency to MDEQ within two (2) working days of the time when emission limitations were exceeded due to the emergency which contained a description of the emergency, any steps taken to mitigate emissions, and corrective actions taken;
- (d) in any enforcement proceeding, the permittee seeking to establish the occurrence of any emergency has the burden of proof;
