S-1	The Permittee shall Submit a quarterly report: Due quarterly, by the 28th of Jan, April, July, and Oct. The report should address the requirements listed in Condition No. L-2 of the permit. [WPC-1 Chapter One]
S-2	The Permittee Shall Submit a plan: Due upon completion of construction. The Inspection plan shall describe all essential inspection points of both the wastewater treatment system and the spray irrigation disposal field, and the frequency at which these inspections shall occur to insure proper operation and maintenance. The Inspection Plan must be submitted to the Department for review and approval prior to placing the treatment system into operation. [WPC-1 Chapter One]
S-3	The Permittee Shall Submit a plan: Due once within 1 month (30 days) after effective date. An approvable groundwater monitoring plan must be submitted to the Mississippi Department of Environmental Quality 90 days after the effective date of the permit. [WPC-1 Chapter One]
S-4	Reporting Requirements - Planned Changes  The permittee shall give notice to the Permit Board as soon as possible of any planned physical alterations or additions, including but not limited to, a change of operation to the permitted facility. Notice is required in the circumstances that follow: (1) The alteration or addition to a permitted facility may meet one of the criteria for determining whether the facility is a new source in 40 CFR 122.29(b); or (2) The alteration or addition could significantly change the nature or increase the quantity of pollutants discharged. This notification applies to pollutants which are not subject to either effluent limitations in the permit or notification requirements under 40 CFR 122.42(a)(1). (3) The alteration or addition results in a significant change in the permittee's sludge use or disposal practices, and such alteration, addition, or change may justify the application of permit conditions that are different from or absent in the existing permit, including notification of additional use or disposal sites not reported during the permit application process or not reported pursuant to an approved land application plan. Any information shall be provided orally within 24 hours from the time the permittee becomes aware of the circumstances. A written submission shall also be provided within 5 days of the time the permittee becomes aware of the circumstances. The written submission shall contain a description of the noncompliance and its cause; the period of noncompliance, including exact dates and times, and if the noncompliance has not been corrected, the anticipated time it is expected to continue; and steps taken or planned to reduce, eliminate, and/or prevent recurrence of the noncompliance. T-10	<p>Duty to Comply</p> <p>The permittee must comply with all conditions of this permit. Any permit noncompliance constitutes a violation of the Clean Water Act and is grounds for enforcement action; for permit termination, revocation and reissuance, or modification; or denial of a permit renewal application. T-11	<p>Proper Operation, Maintenance and Replacement</p> <p>The permittee shall at all times properly operate, maintain, and when necessary, promptly replace all facilities and systems of collection, treatment and control (and related appurtenances) which are installed or used by the permittee to achieve compliance with the conditions of this permit.
