Beginning upon completion and start-up of improvements needed to comply with Phase II limitations or five (5) years after the issuance of the permit, whichever comes first, the permittee shall achieve compliance with the effluent limitations specified for the parameters noted as Phase II; Phase I limitations shall not apply at this time. The permittee shall notify our office orally at least 48 hours prior to start-up and in writing no later than 5 days after start-up. Effluent limits have been developed such that the waste treatment system should protect water quality. However, this permit is subject to modifications if future evidence, monitoring results, or nuisance conditions indicate that a higher degree of treatment is required to maintain water quality.The discharge from this facility shall cease and connection made to a regional sewer system when the sewer system is available in the area. At that time the discharge from the system shall be terminated.In accordance with the Municipal and Domestic Water and Wastewater System Operator's Certification Act of 1986, this treatment facility must be operated by persons who are certified as qualified to operate the facility. The Office of Pollution Control must concur with plans and specifications for the installation or modification of the wastewater treatment facility and sewer collection system, if applicable, prior to the commencement of construction.
