T-2	This permit authorizes irrigation and dust-control activities using only leachate generated by the Pecan Grove Sanitary Landfill that has been treated with the Saltworks Technologies, Inc., SaltMaker™ treatment system or other treatment system approved by the Mississippi Department of Environmental Quality. The permittee shall conduct these activities in a manner that prevents discharge in accordance with the approved application. [11 Miss. Admin. Code Pt. 6, Ch. 1, Subch. 1. 4.]
T-3	Use of treated leachate for irrigation shall be confined to covered landfill slopes to aid in vegetative growth while its use for dust control shall occur on access roads and other locations as needed within the landfill footprint. This Closure Plan shall address how and when all manufactured products, by-products, raw materials, stored chemicals, and solid and liquid waste and residues will be removed from the premises or permanently disposed of on site such that no potential environmental hazard to the waters of the State will be presented.
