Pursuant to Section 401 of the Federal Water Pollution Control Act (33 U. S. C. 1251, 1341), the Office of Pollution Control (OPC) issues this Certification, after public notice and opportunity for public hearing, to Ruth Horn, an applicant for a Federal License or permit to conduct the following activity:

Ruth Horn, Bulkhead and Boat Shelter: Proposed project to replace an existing 217 linear foot bulkhead and an existing 40-foot wide by 52-foot long covered, open-sided boat shelter. This project is located along the shoreline of Beardslee Lake at 5419 Beardslee Street in Moss Point, Jackson County, Mississippi [SAM201600805DEM, WQC2016039].

The Office of Pollution Control certifies that the above-described activity will be in compliance with the applicable provisions of Sections 301, 302, 303, 306, and 307 of the Federal Water Pollution Control Act and Section 49-17-29 of the Mississippi Code of 1972, if the applicant complies with the following conditions:


1. Pilings shall be steel, concrete, plastic, vinyl, or timber treated with chromated copper arsenate (CCA).
2. Special care shall be taken prior to and during construction to prevent the movement of sediment into the adjacent waters.
3. Turbidity outside the limits of a 750-foot mixing zone shall not exceed the ambient turbidity by more than 50 Nephelometric Turbidity Units.

4. No sewage, oil, refuse, or other pollutants shall be discharged into the watercourse.

The Office of Pollution Control also certifies that there are no limitations under Section 302 nor standards under Sections 306 and 307 of the Federal Water Pollution Control Act which are applicable to the applicant's above-described activity.

This certification is valid for the project as proposed. Any deviations without proper modifications and/or approvals may result in a violation of the 401 Water Quality Certification. If we can be of further assistance, please contact us.
