T-29	Bypassing - Definitions "Bypass" means the intentional diversion of waste streams from any portion of the permittee's treatment facility. "Severe property damage" means substantial physical damage to property, damage to the treatment facilities which causes them to become inoperable, or substantial and permanent loss of natural resources which can reasonably be expected to occur in the absence of a bypass.
