Notice is required in the circumstances that follow:</p> <ul style="list-style-type: none"><li>(1) The alteration or addition to a permitted facility may meet one of the criteria for determining whether the facility is a new source in 40 CFR 122.29(b); or</li><li>(2) The alteration or addition could significantly change the nature or increase the quantity of pollutants discharged. A written submission shall also be provided within 5 days of the time the permittee becomes aware of the circumstances. Proper operation and maintenance includes adequate laboratory controls and appropriate quality assurance procedures.
