- (2) The following shall be included as information which must be reported within 24 hours under this paragraph.
- (i) Any unanticipated bypass which exceeds any effluent limitation in the permit.
- (ii) Any upset which exceeds any effluent limitation in the permit.
- (iii) Violation of a maximum daily discharge limitation for any of the pollutants listed by the Permit Board in the permit to be reported within 24 hours.
