Condition Condition No. Parameter L-1 The wastewater treatment and disposal system for this project must protect water quality. This permit is subject to modification if future evidence, monitoring results, or other information indicates that surface water quality is being adversely affected. This permit may be modified to require monitoring of surface water if needed to ensure that water quality is being protected. Operation of the wastewater treatment and disposal system for this project shall cease and connection made to a regional or municipal sewer system when available in the area. The volume of flow (GPD) for the influent to the treatment and land application system shall not exceed 4914 gallons per day (initial 39 lots). Any increase in flow for the influent from 4914 gallons per day (initial 39 lots) must be approved by the Office of Pollution Control. In accordance with the Municipal and Domestic Water and Wastewater System Operator's Certification Act of 1986, this treatment facility must be operated by persons who are certified as qualified to operate the facility.
