This permit may be modified to require monitoring of surface water if needed to ensure that water quality is being protected.</p> <p>Operation of the wastewater treatment and disposal system for this project shall cease and connection made to a regional or municipal sewer system when available in the area.</p> <p>The volume of flow (GPD) for the influent to the treatment and land application system shall not exceed 4914 gallons per day (initial 39 lots). Proper operation and maintenance includes adequate laboratory controls and appropriate quality assurance procedures.
