The Water Quality Standards of Mississippi require that all waters be free from substances in concentrations or combinations which are harmful to human, animals, or aquatic life (State of Mississippi, Water Quality Criteria for intrastate and Coastal Waters, Section II.4., Minimum Conditions Applicable to All Waters, page 3, adopted March 22, 1990). In accordance with such requirements, the permittee is authorized to discharge from outfall 001 only in accordance with the following conditions:
