Pursuant to Section 401 of the Federal Water Pollution Control Act (33 U. S. C. 1251, 1341), the Office of Pollution Control (OPC) issues this Certification, after public notice and opportunity for public hearing, Paul Campbell, an applicant for a Federal License or permit to conduct the following activity:

Vicksburg Petroleum Products LLC: An after-the-fact Department of the Army Permit for construction of an access road, two levees and the expansion of an existing rock yard. The purpose of this project was to construct an access road to replace Kemp Bottom Road, which was damaged by water erosion, and made impassable in recent flood events, improve existing levees adjacent to the facility, and to expand an existing rock yard to meet current demands. The project filled approximately 1.61 acres of emergent wetlands, which drains into an unnamed tributary of Hennessey Bayou. The access road is approximately 30 feet wide by 1,700 feet long. The levee along the south side of the road is approximately 70 feet wide by 1,750 feet long. The levee to the east of the Entergy Plant is approximately 70 feet wide by 255 feet long. The expanded rock yard is approximately 13.20 acres. Approximately 5,250 cubic yards of silty clay loam was placed within jurisdictional wetlands. No additional work is proposed. Mitigation has been proposed through the purchasing of credits from an approved mitigation bank. The site is located in Vicksburg, Warren County, Mississippi. [MVK2018108, WQC20180025].

The Office of Pollution Control certifies that the above-described activity will be in compliance with the applicable provisions of Sections 301, 302, 303, 306, and 307 of

the Federal Water Pollution Control Act and Section 49-17-29 of the Mississippi Code of 1972, if the applicant complies with the following conditions:

1. All fill material and excavation areas shall have side slopes of at least 3:1 (horizontal: vertical) and shall be immediately seeded, stabilized and maintained.
2. Appropriate best management practices (BMPs) shall be properly installed and maintained to prevent the movement of sediment off-site and into adjacent drainage areas. In the event of any BMP failure, corrective actions shall be taken immediately.
3. No sewage, oil, refuse, or other pollutants shall be discharged into the watercourse.

The Office of Pollution Control also certifies that there are no limitations under Section 302 nor standards under Sections 306 and 307 of the Federal Water Pollution Control Act which are applicable to the applicant's above-described activity.

This certification is valid for the project as proposed. Any deviations without proper modifications and/or approvals may result in a violation of the 401 Water Quality Certification. If we can be of further assistance, please contact us.
