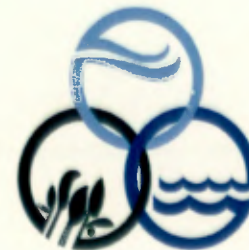

Severe property damage does not mean economic loss caused by delays in production. [40 CFR 122.41(m)]</p>
