MINING NOTICE OF INTENT (MNOI) FOR COVERAGE UNDER

MINING STORM WATER, DEWATERING AND NO DISCHARGE GENERAL PERMIT MSR32 2 422

File at least 30 days prior to the commencement of mining; 15 days if a Storm Water Pollution Prevention Plan (SWPPP) is already on file and mine dewatering is not proposed. Lateral expansion of an existing mine that has general permit coverage requires the submittal of the Major Modification Form, not a new MNOI (modification of the existing SWPPP to include the expansion is required). Discharge of storm water or impounded water associated with mining or the operation of a wastewater recirculation system with no discharge without written notification of coverage from MDEO is a violation of State Law.
