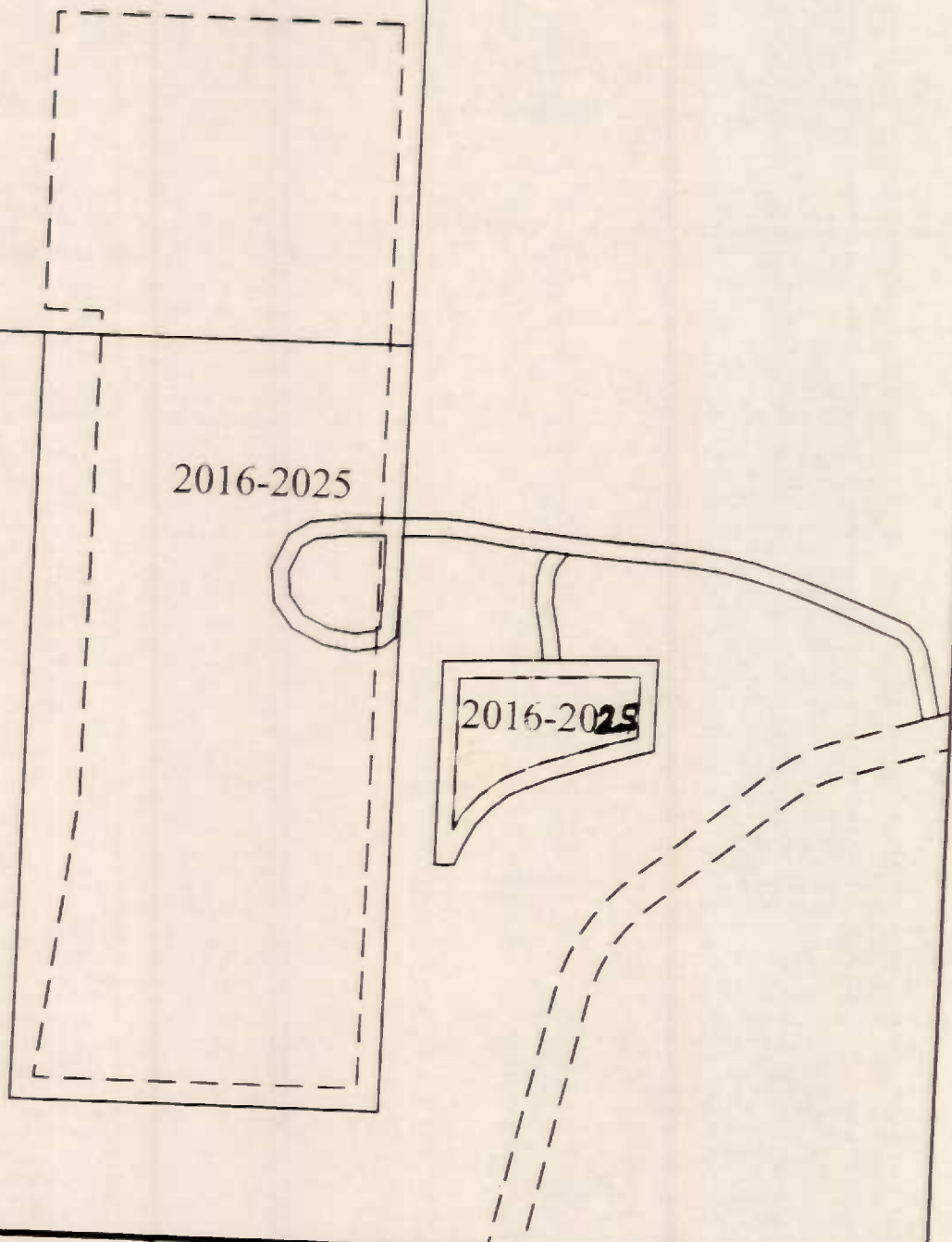

VSG Mine 1 is located within the Heidelberg Quadrangle.

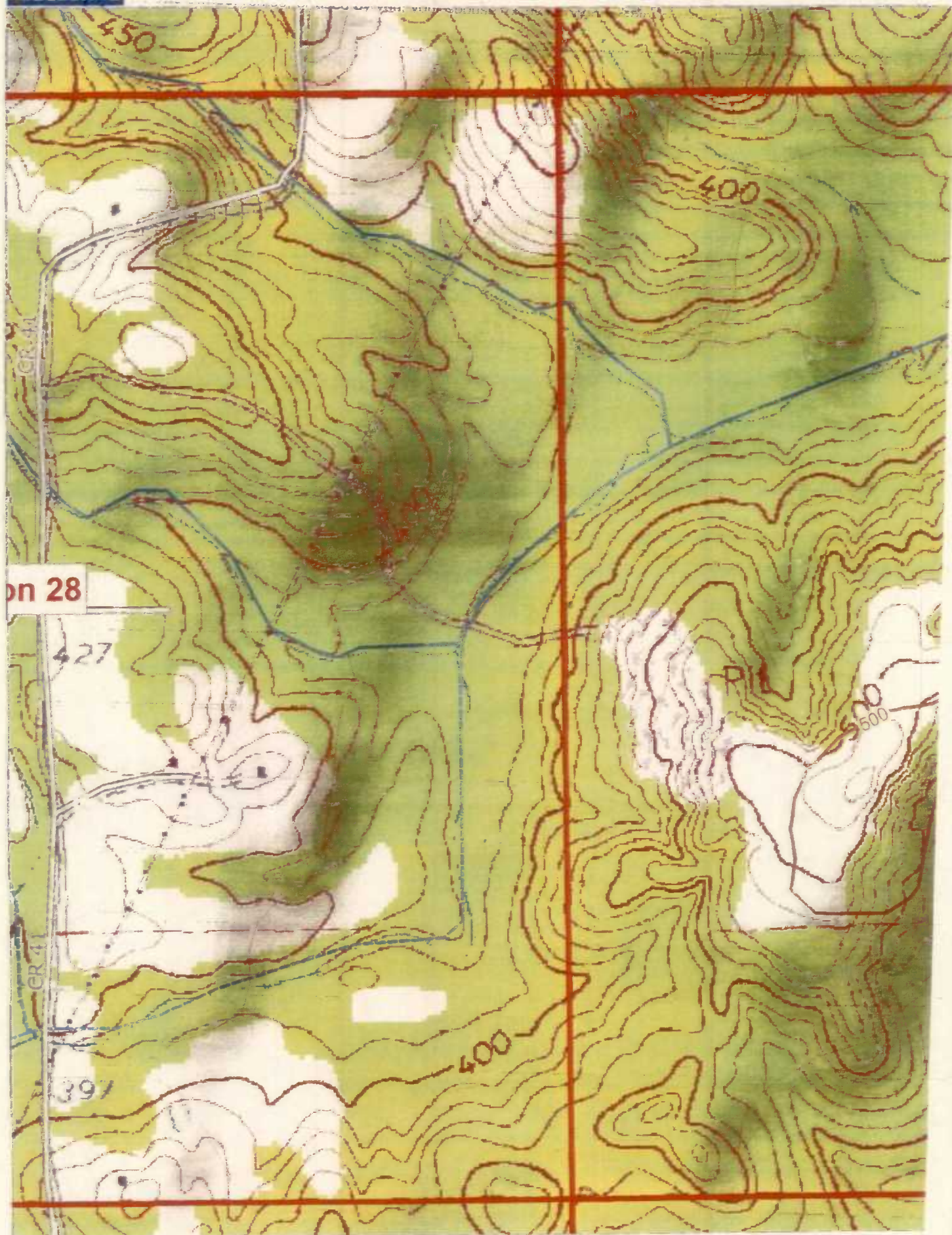
