

1997 LAYOUT PLAT



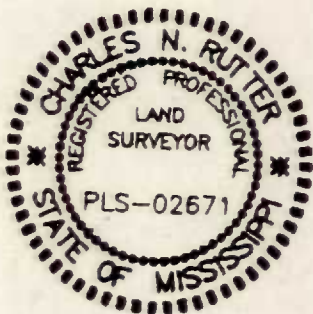
