Florence and Rajeev – I am asking Rajeev to handle this request but I have been looking and it and researching it a little bit and I am confused. If Rajeev can handle it then he will but if it gets too convoluted then Florence I will assign back to you and let you know via email.

GP requested to have Outfall 002 removed from their WDLS coverage. There are 3 WDLS ponds and 3 outfalls in the coverage. In the cover letter they indicate that the river backs up into the pond for Outfall 002 and want to remove the culvert and therefore remove the outfall from the coverage. Rajeev, I don't know how we could possibly allow someone to utilize a pond but not permit it because the stream backflows into it. We have to permit an outfall from each pond that is used for WDLS. I think the answer is that it was not designed properly and they need to fix it so that the stream will not backflow into it. Maybe build up the berms. Not quite sure of other options for them.

GP requested to remove 4 outfalls from Baseline. The thing I'm most confused about here is there are no outfalls in enSite for Baseline. I'm not sure if they are identified in the SWPPP or not. How many outfalls does Baseline cover? Are there only 4 outfalls in Baseline? I'm not sure if they even need a Baseline.

I spoke with Tyler McIntyre in ECED he inspected the WDLS in June. They talked to him about removing some outfalls but I think they were showing him WDLS outfalls but also Baseline outfalls. I think they confused him.

Rajeev, you probably need to speak with GP's Rand Mathews who submitted both requests. Sorry to put this one on you Rajeev, but I think it is better if one person tries to figure out what is happening at this site. If they need a Baseline you can
