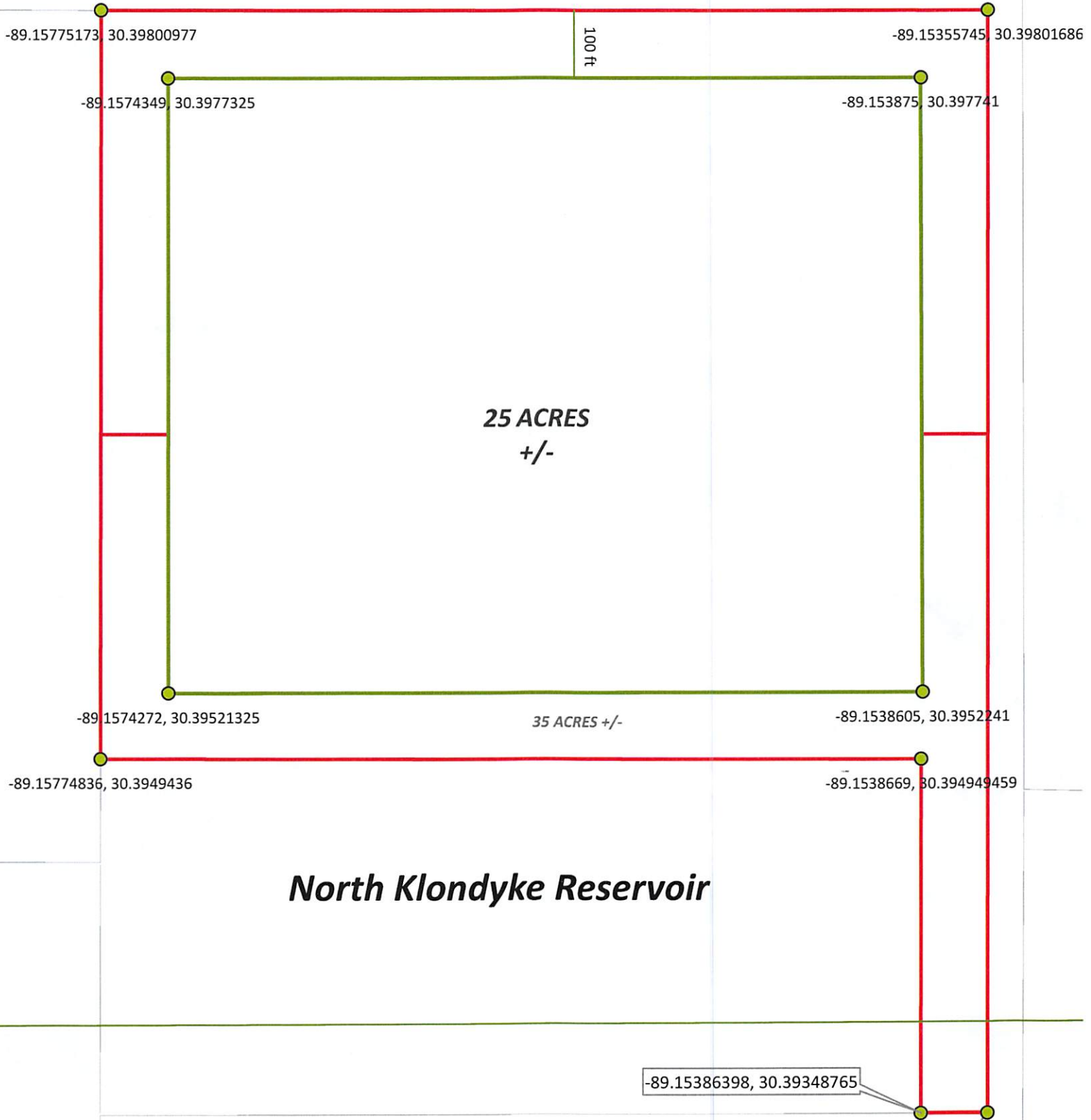

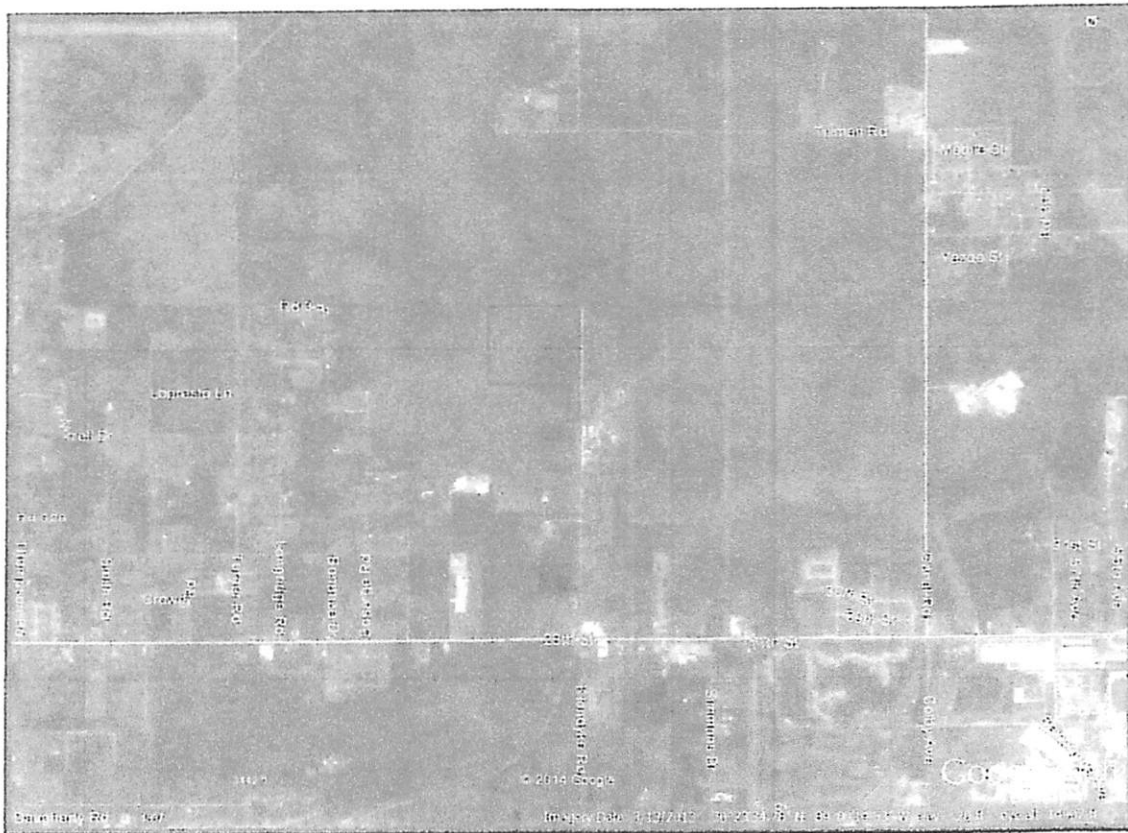

Letter of Instruction for Large Construction Re-Coverage
Harrison County

The Permit Board on Environmental Quality has reissued the general permit that authorizes the discharge of storm water associated with construction activity. The Large Construction Storm Water General Permit (MSR10) was reissued on February 4, 2022. This general permit authorizes the discharge of storm water from construction sites that disturb five (5) or more acres by clearing, grading, excavating, or other land-disturbing activities. This permit replaces the previous general permit that expired on December 31, 2021. The permit is reissued for a five-year period that will expire on January 31, 2027.

A regulated activity that was granted coverage under the previous general permit may seek recoveage under the reissued general permit. To remain covered under a valid general permit, the coverage recipient must complete the enclosed "Re-Coverage Form" and send it to the indicated address by April 30, 2022. A re-submittal of the Storm Water Pollution Prevention Plan (SWPPP) is not required, even if amendments must be added to meet new permit conditions. However, amendments to the SWPPP must be submitted with the "Re-Coverage Form" if there has been a change in design which may increase the discharge of pollutants to waters of the State or the current SWPPP proves to be ineffective in controlling storm water pollutants.

Forms to transfer the coverage to a new owner or to terminate the coverage if construction activities are completed and the site has achieved final stabilization can be found at: <https://www.mdeq.ms.gov/construction-stormwater/>.

A new Certificate of Permit Coverage will not be mailed to the coverage recipient. Coverage recipients should access and print their Certificate of Coverage from the MDEQ website. Additional information can be found at: <https://www.mdeq.ms.gov/construction-stormwater/>. If a coverage recipient does not have access to the internet, MDEQ will mail a certificate of coverage only upon request. Please keep a copy of the signed and completed "Re-Coverage Form" as proof of coverage until the certificate of coverage can be obtained. **MINING NOTICE OF INTENT (MNOI)
FOR COVERAGE UNDER
MINING STORM WATER, DEWATERING AND NO DISCHARGE

File at least 30 days prior to the commencement of mining; 15 days if a Storm Water Pollution Prevention Plan (SWPPP) is already on file and mine dewatering is not proposed. Lateral expansion of an existing mine that has general permit coverage requires the submittal of the Major Modification Form, not a new MNOI. However, modification of the existing SWPPP to include the expansion is required. Discharge of storm water or impounded water associated with mining or the operation of a wastewater recirculation system with no discharge without written notification of coverage from MDEQ is a violation of State Law.

If the company seeking coverage is a corporation, a limited liability company, a partnership, or a business trust, attach proof of its registration with the Mississippi Secretary of State and/or its Certificate of Good Standing. This registration or Certificate of Good Standing must be dated within twelve (12) months of the date of the submittal of this coverage form. Coverage will be issued in the company name as it is registered with the Mississippi Secretary of State.
