Dear Mr. Gupta,

Please find attached Permit Modification Form for Industrial Stormwater General Permit Coverage Number MSR000572 for Georgia-Pacific WFS LLC's Meridian Woodyard (GP).

This modification is the result of GP's closure of its adjacent Meridian Wet Deck covered under MDEQ's Wet Deck Log Spray with Recirculation Permit # MSG170053 to which GP submitted Request for Termination of Coverage dated March 29, 2023.

From the Wet Deck closure, 6.6 acres of area has been added to the Meridian Woodyard dry log storage area and Outfall 003 has been added to monitor stormwater discharge from this additional acreage. The Meridian Woodyard now has two outfalls – Outfall 001 and recently added Outfall 003.

The additional acreage and outfall added are shown on the attached maps and further described in the updated Storm Water Pollution Plan (SWPPP) for the Site also attached.

Thank you for your assistance in the matter of this permit modification and our prior request for termination of the wet deck permit. If you have questions or need further information , please contact me using one of the points listed at the top of this letter.
