Conventional storm water management systems may need to be supplemented with flocculants to meet state water quality standards. (2) Systems utilizing polymer flocculants to treat turbidity from storm water discharges must meet the following minimum criteria.

(A) Polymer shall be introduced through turbulent mixing into the storm water upstream of sedimentation BMPs,

(B) If a sedimentation basin is constructed then it shall provide at least 3,600 cubic feet (133 cubic yards) of storage per acre drained. Sediment basins must be installed before initial site grading and utilize outlet structures that withdraw water from the surface and that are designed for a minimum 2-year, 24-hour storm event.
