Pursuant to your letter of instruction, we understand that the Hydrostatic Test General Permit (HTGP – MSG13) was reissued on March 21, 2017. American Tank & Vessel, Inc. (AT&V) is enclosing a completed Hydrostatic Test General Permit Re-Coverage Form, as well as a certificate of good standing from the Mississippi Secretary of State's website. After reviewing the reissued General Permit, we are aware that coverage is intended for facilities with "sporadic" discharges of hydrostatic test water to waters of the state from new or used pipelines, storage tanks, flowlines, etc., used for transportation or storage of natural gas, crude oil, or liquid or gaseous petroleum hydrocarbons, or other substances which would adequately be detected by the effluent limitations in this permit. It is our understanding that AT&V operations meet these eligibility requirements and, therefore, should be granted coverage under the reissued General Permit. AT&V's discharges are sporadic in nature, as they have historically occurred no more than 2 times per month. All hydrostatic test water discharges to an onsite retention pond which rarely discharges offsite (i.e., typically twice per reporting period or less).

Hydrostatic testing is dependent upon the number of tanks manufactured during a given reporting period and occurs upon completion of each tank to identify any areas of incontinence before being transported to customers commonly within the oil and gas industry where storage of natural gas, crude oil, and/or other petroleum products take place. Since the General Permit specifically includes new storage tanks, we do not believe there will be pollutants introduced that were not contemplated during the development and reissuance of the General Permit.
