This permit is subject to modification if future evidence, monitoring results, or other information indicates that surface water quality is being adversely affected. This permit may be modified to require monitoring of ground or surface water if needed to ensure that water quality is being protected.</p> <p>Connection shall be made to a regional or municipal sanitary sewer system when a system is available in the area. Upon such connection, use of the on-site disposal system shall be terminated.</p> <p>In accordance with the Municipal and Domestic Water and Wastewater System Operator's Certification Act of 1986, this treatment facility must be operated by persons who are certified as qualified to operate the facility.</p> <p>The volume of flow (MGD) for the influent to the on-site spray field shall not exceed 0.245 MGD. Any increase in flow for the influent from 0.245 MGD must be approved by the Office of Pollution Control.</p> <p>. [WPC-1 Chapter One]</p>
