Georgia-Pacific WFS LLC requests the removal of the outfall identified below be made to the Wet Deck Recirculating permit at the Leaf River Remote Woodyard facility.

In review of this site, it has been determined that the outfall mentioned above does not discharge from our site. In heavy rain occurrences, this outfall will backflow onto our property from the Leaf River. We propose removing this Outfall culvert to prevent backflow of the river onto our site. This was also discussed with Tyler McIntyer with MS DEQ during our May 27, 2020 compliance inspection.
