This permit is subject to modification if future evidence, monitoring results, or other information indicates that surface water quality is being adversely affected. This permit may be modified to require monitoring of surface water if needed to ensure that water quality is being protected.</p> <p>Operation of the wastewater treatment and disposal system for this project shall cease and connection made to a regional or municipal sewer system when available in the area. Spray head orientation shall be such to minimize aerosol drift and stripping of volatile compounds.</p> <p>Storm water runoff and all wastewater associated with the facility shall be managed in a manner to prevent a discharge to State waters.</p> <p>Prior to the 1st of October of each year the storage lagoons shall be pumped down to a depth that will provide a maximum storage volume of rainfall and wastewater needed to winter storage. Pump-out shall be performed only when the moisture condition of the soil is below field capacity and effluent shall be applied at rates that will prevent runoff of effluent.
