M-2		<p>MONTHLY SITE INSPECTIONS:</p> <p>Routine visual site inspections shall be performed at a minimum of once per month to ensure the effectiveness of the SWPPP's design and implementation. If feasible, the inspections should be conducted during or after storm events. All areas contributing to storm water discharges associated with industrial activity (including, but not limited to, ground storage piles, tanks, hoppers, silos, dust containment/collection systems, cleaning, and maintenance areas) must be visually inspected as often as needed, but no less than once monthly. The inspection must evaluate whether the SWPPP adequately minimizes pollutant loadings and is properly implemented in accordance with the terms of this permit or whether additional control measures are needed. This includes observing storm water discharges for obvious industrial storm water pollution such as color, lack of clarity, floating solids, settled solids, suspended solids, foam, odor and oil sheens. If a SWPPP has already been developed and implemented, the permittee shall review the existing SWPPP and revise it, if necessary, within 180 days of permit issuance to incorporate the requirements of the permit specified herein. The SWPPP shall be prepared in accordance with sound engineering practices and shall identify potential sources of pollution, which may reasonably be expected to affect the quality of storm water discharges associated with industrial activity from the facility. The SWPPP shall describe and ensure the implementation of best management practices, which will reduce pollutants in storm water discharges and assure compliance with the terms and conditions of this permit.
