If the facility is out of business or no longer a regulated facility, please request termination of coverage by completing the Request for Termination (RFT) Form found in the Industrial Stormwater Forms Package. Facilities that continue to discharge wastewater without applicable permit coverage are in violation of state law.



Please see the enclosed Industrial Stormwater General Permit Re-Coverage Form for our sites at: 323 Leggett Dr Richland, MS 39218 and 150 George T Thompson Dr Tupelo, MS 38801.

I wanted to explain how Southeastern Freight Lines Inc is addressing the deficiencies in Mississippi so you have an understanding of our process going forward. I was hired as the Environmental Compliance Manager for Southeastern a couple of months ago and have been evaluating all of our sites throughout our territory. There have been areas of concern and as such, I have hired consulting firms to conduct site visits at all of our facilities in order to update SWPPPs and SPCCs as needed. Our consultant will be in Mississippi next month, however, I emailed Ms. Becky Williams, CPM (Chief, Water II Branch) to see if she could give me some direction. She stated it would be better for us to submit the Re-Coverage prior to the site visit, and should we need to update the SWPPP, submit that at a later date.
