Condition No.	Parameter	Condition
L-1		Any lagoon, sedimentation pond, or dredge pit must have an emergency discharge structure installed at least 24 inches above the normal operating fluid level, said discharge structure being at least 24 inches below the lowest point on the top of the containment dike. [11 Miss. Admin. Code Pt. 6, Ch. 1, Subch. 1.]
L-2		Dikes and any other appurtenant structures must be constructed utilizing good engineering designs, standards, methodologies and materials. [11 Miss. Admin. Code Pt. 6, Ch. 1, Subch. 1.]
L-3		Dikes shall be maintained in good working order at all times. There shall be no leaks through dikes, any damaged dike shall be replaced or repaired immediately upon discovering any deficiency, and all earthen dikes shall be maintained with adequate cover, such that the effects of erosion are minimized. [11 Miss. Admin. Code Pt. 6, Ch. 1, Subch. 1.]
L-4		The permittee shall maintain level-measuring devices for the purpose of determining the depth of each storage lagoon. These measuring devices shall remain accessible to the permittee and other qualified personnel for recording and inspection purposes. [11 Miss. Admin. Code Pt. 6, Ch. 1, Subch. 1.]
L-5		Prior to the 1st of October of each year the storage lagoons shall be pumped down to a depth that will provide a minimum storage volume equivalent to 150 days of rainfall and wastewater needed for winter storage. Pump-out shall be performed only when the moisture condition of the soil is below field capacity and effluent shall be applied at rates that will prevent runoff of effluent. Effluent application shall not occur during rainfall, when heavy rainfall is predicted, or immediately thereafter. Effluent application is prohibited between 1st of October and 1st of March. If cool season grasses are present, the facility may apply until 1st of November. [11 Miss. Admin. Code Pt. 6, Ch. 1, Subch. 1.]
L-6		The permittee shall maintain a minimum of three inches of vegetative cover during the growing season. [11 Miss. Admin. Code Pt. 6, Ch. 1, Subch. 1.]
L-7		The permittee shall harvest the vegetative cover at regular intervals. [11 Miss. Admin. Code Pt. 6, Ch. 1, Subch. 1.]
L-8		Spray head orientation shall be such to minimize aerosol drift and stripping of volatile compounds. [11 Miss. Admin. Code Pt. 6, Ch. 1, Subch. 1.]

S-1	<p>Reporting Requirements - Planned Changes</p> <p>The permittee shall give notice to the Permit Board as soon as possible of any planned physical alterations or additions, including but not limited to, a change of operation to the permitted facility. Notice is required in the circumstances that follow:</p> <p>(1) The alteration or addition to a permitted facility may meet one of the criteria for determining whether the facility is a new source in 40 CFR 122.29(b); or</p> <p>(2) The alteration or addition could significantly change the nature or increase the quantity of pollutants discharged. This notification applies to pollutants which are not subject to either effluent limitations in the permit or notification requirements under 40 CFR 122.42(a)(1).</p> <p>(3) The alteration or addition results in a significant change in the permittee's sludge use or disposal practices, and such alteration, addition, or change may justify the application of permit conditions that are different from or absent in the existing permit, including notification of additional use or disposal sites not reported during the permit application process or not reported pursuant to an approved land application plan. S-3	<p>Noncompliance Notification - Twenty-Four Hour Reporting</p> <p>(1) The permittee shall report any noncompliance which may endanger health or the environment. Any information shall be provided orally within 24 hours from the time the permittee becomes aware of the circumstances. A written submission shall also be provided within 5 days of the time the permittee becomes aware of the circumstances. The written submission shall contain a description of the noncompliance and its cause; the period of noncompliance, including exact dates and times, and if the noncompliance has not been corrected, the anticipated time it is expected to continue; and steps taken or planned to reduce, eliminate, and/or prevent recurrence of the noncompliance. The Executive Director may waive the written report on a case-by-case basis for reports under this section if the oral report has been received within 24 hours. [11 Miss. Admin. T-9	<p>Proper Operation, Maintenance and Replacement</p> <p>The permittee shall at all times properly operate, maintain, and when necessary, promptly replace all facilities and systems of collection, treatment and control (and related appurtenances) which are installed or used by the permittee to achieve compliance with the conditions of this permit. Proper operation and maintenance includes adequate laboratory controls and appropriate quality assurance procedures. Proper replacement includes maintaining an adequate inventory of replacement equipment and parts for prompt replacement when necessary to maintain continuous collection and treatment of wastewater. This provision requires the operation of back-up or auxiliary facilities or similar systems that are installed by a permittee only when the operation is necessary to achieve compliance with the conditions of the permit. T-13	<p>Bypassing- Prohibition of Bypass</p> <p>(1) Bypass is prohibited, and the Commission may take enforcement action against a permittee unless:</p> <ul style="list-style-type: none">(i) Bypass was unavoidable to prevent loss of life, personal injury, or sever property damage.(ii) There was no feasible alternatives to the bypass, such as the use of auxiliary treatment facilities, retention of untreated wastes, or maintenance during normal periods of equipment downtime. In the event of investigation during an emergency response action, a reasonable time shall be any time of the day or night.
