The plan shall also include the monitoring of weather conditions both 24 hours before and 24 hours after make-up water is used. An approved plan and any approved modification thereto, shall become an enforceable condition of the permit. [11 Miss. Admin. Code Pt. 6, R. 1.1.4.A(4).]

Effluent Discharge Allowed? - an effluent discharge is allowed as long as the "Stream Flow (cfs)" is equal to or greater than 11 cfs.

Stream Flow (MGD) - can be calculated by taking the "Stream Flow (cfs)" and dividing it by 1.547.

Percent Ratio - The percent ratio shall be calculated by taking the "Effluent Flow (MGD)" (EF) and dividing it by the "Stream Flow (MGD)" (SF) plus the "Effluent Flow (MGD)" (EF) and multiplying this number by 100.

$$\text{Percent Ratio} = \frac{\text{EF}}{\text{SF} + \text{EF}} * 100$$

Excursion - An excursion will occur if the any of the following occur:

1. If an effluent discharge occurs when the stream flow is below 11 cfs (7.11 MGD).
2. If the percent ratio is above 3.7 %, when the stream flow is between 7.11 MGD and 16.79 MGD.
3. If the percent ratio is above 6.25 %, when the stream flow is equal to or greater than 16.8 MGD.

Actual Permit Language

The effluent shall not be discharged to the receiving stream when the stream flow is less than 11.0 cfs. A dilution ratio of 26:1 (stream flow to total facility wastewater flow) shall be maintained until such time that the stream flow is equal to or greater than 26 cfs. At that time a dilution ratio of 15:1 (stream flow to total facility wastewater flow) shall be maintained.
