Dear Ms. Ferdinand:

As you are aware, the following violation was identified during a Compliance Evaluation Inspection (CEI):

1. **Violation of Miss. Code Ann. 49-17-29 2(b)**

The Mississippi Department of Environmental Quality (MDEQ) has not received an official response regarding this violation. It has been decided to place Big Red Towing and Hauling Auto LLC on an Informal Compliance Schedule (ICS) until compliance with Miss. Code Ann. 49-17-29 2(b).

To resolve the violation, one of the following actions should be taken by **September 23, 2024**:

1. Obtain permit coverage.
 - a. Submit an accurate and complete Industrial Stormwater Notice of Intent and a completed Storm Water Pollution Prevention Plan (SWPPP) to MDEQ's Environmental Permits Division.
 - i. The majority of our facilities hire a civil or environmental engineer to do

this. You can also work with MDEQ's Office of Community Engagement for help. <https://www.mdeq.ms.gov/about-mdeq/office-of-community-engagement/sbeap/>

2. Terminate the permit should the site no longer be operational.
 - a. Submit a request for termination form to MDEQ along with pictures of the site being closed and all equipment, vehicles, and potential sources of pollution having been removed. Following this, MDEQ staff may perform a follow-up site visit.
3. Transfer of permit coverage.
 - a. Should you have sold the site, the new entity shall have to obtain permit coverage, and the permit will have to be transferred.

Upon completion of the previously listed actions and demonstration of compliance with the permit requirements, Big Red Towing and Hauling Auto LLC may be removed from its ICS. **Failure to submit this information to MDEQ may result in enforcement action, which may include the levying of monetary penalties.**

Preparedness

1. Safeguard against spills.
2. Clean up all significant spills immediately with rags (interior) or sand (exterior).

Prevention

1. Do not remove engines, transmissions or oil pans on rear outside storage area.
2. When necessary use sand to prevent seepage into the ground.

Spill Control

1. Use oil pans and barrels, when necessary, under the covered storage area.
2. Clean all significant spills with rags or sands.

Good Housekeeping Rules

1. Inspect containers for leaks and spills.
2. Inspect equipment for leaks.
3. Collected fluids will be recycled as necessary.
4. Report any deficiencies to Irma Ferdinand (601)542-0005 1020 2nd Street Osyka, Ms 39657.

Spill Prevention and Response

1. When removing engines, transmissions and etc. place collection containers under vehicle when necessary.
2. If spill is detected remove soiled sand to check for possible seepage.
