Section 1.0 – Introduction

Circle K Store #3747 is currently an active Leaking Underground Storage Tank (LUST) site with the Mississippi Department of Environmental Quality (MDEQ). Several soil borings and monitor wells exceed MDEQ cleanup levels for soil and groundwater. Jones Environmental, Inc. is currently drafting a Turnkey Remedial Action Plan (TRAP) which addresses elevated soil and groundwater concentrations.

The proposed remedial action method is a Dual Phase Extraction remediation system. This system consists of multiple recovery wells, utilized for the hydraulic capture of contaminated groundwater and volatilized hydrocarbon vapors. Recovery wells containing submersible pumps will be used for extraction of groundwater. These submersible pumps will be utilized to direct recovered groundwater through an onsite treatment system consisting of an oil water separator, air stripper and Granular Activated Carbon (GAC) vessels.

All recovered and treated groundwater will be discharged to the wastewater collection line south of the proposed system location, serviced by West Rankin Utility Authority Wastewater Treatment Facility and the Town of Flowood. Prior to any discharge of treated water, a groundwater discharge permit, will be obtained under Mississippi's Underground Storage Tank Groundwater Remediation General Permit (MSG12). The application for the preceding permit is attached as Appendix A.

Section 2.0 – Outfall Map

Provided with the application is a portion of a quadrangle map named "Jackson Quadrangle, Mississippi, 7.5-Minute Series" and is attached as Appendix B with a half-mile outfall radius.

Section 3.0 – Contiguous Landowner Notifications

As required by the MDEQ, all contiguous landowners were sent documentation, the attached Contiguous Landowner Notification Form in Appendix C, detailing the site location and a brief description of work to be undertaken. Owner addresses used for notification were based on publicly available government land records. All signed return receipts received are included with the form. In lieu of signatures acknowledging receipt, delivery attempts will be provided via tracking number information.

Section 4.0 – Proposed Water Treatment Chemicals

Direct influent treatment is performed purely mechanically as the water passes through an air scrubber, Oil-Water Separator (OWS), bag filters and activated carbon vessels to remove influent concentrations prior to discharging as effluent. No chemical treatment is proposed and no safety data sheets are attached.

(NOT TO SCALE)




**TURNKEY REMEDIAL ACTION PLAN SCOPE OF WORK
