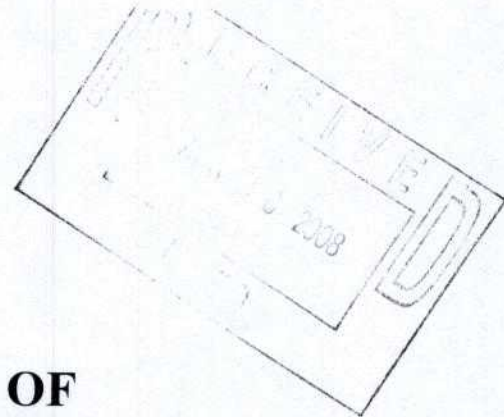

FOR COVERAGE UNDER LARGE CONSTRUCTION STORM WATER
GENERAL NPDES PERMIT MSR10 5063

INSTRUCTIONS

Applicant must be owner or prime contractor. The owner(s) of the property and the prime contractor associated with regulated construction activity on the property have joint and several responsibility for compliance with the Large Construction Storm Water General Permit MSR10.

File at least thirty (30) days prior to the commencement of construction, fifteen (15) days if a Storm Water Pollution Prevention Plan (SWPPP) is already on file. Discharge of storm water from a construction site without written notification of coverage is a violation of state law.

Submittals with this CNOI include:

- A Storm Water Pollution Prevention Plan as described in the Large Construction General Permit Part III
- A USGS quad map or a copy showing site location

Additional submittals may include the following if applicable:

- Appropriate Section 404 documentation from U.S. Army Corps of Engineers
- Appropriate documentation from Health Department and/or MDEQ Office of Pollution Control (OPC) concerning future disposal of sanitary sewage and sewage collection system construction
- Appropriate documentation from MDEQ Office of Land & Water, concerning dam construction and low flow requirements


