AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Genesis Rail Services, LLC, Natchez Terminal, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated January 24, 2015, Respondent was contacted by Complainant and notified of the following violation(s) at its facility located at 120 L E Barry Road, Natchez, Mississippi in Adams County:

- A. The facility failed to utilize the sulfatreat catalyst system while barge loading which is a violation of Condition L-6 of the facility's Synthetic Minor Operating Permit (SMOP) No. 0040-00054.
- B. The facility failed to submit a fill notification for Tank 30031 which is a violation of 40 CFR 60.113b(a)(5).

2.

In lieu of a formal enforcement hearing concerning the violation(s) listed above, Complainant and Respondent agree to settle this matter as follows:

A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the

amount of \$60,000. Respondent shall pay this penalty to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director. The settlement payment shall be submitted to:

B. Respondent also agrees to complete and submit a new SMOP application to MDEQ's permitting division by July 1, 2015.

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

4.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

5.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. § 49-17-31, and that it has made an informed waiver of that right.
