AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Olive Properties, LLC, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated March 1, 2016, Respondent was contacted by Complainant and notified of the following violations of Mississippi Large Construction Storm Water General Permit Certificate of Coverage MSR106359. The violations were discovered during a Compliance Evaluation Inspection (CEI) conducted at Respondent's Audubon Woods Subdivision construction project located off of Wirtz Road, Flowood, Mississippi in Rankin County:

- A. Violation of ACT6 S-2 (9): Failure to perform maintenance of erosion and sediment controls.
- B. Violation of ACT6 S-4 (1) & (2): Failure to perform weekly inspections.

At an Administrative Conference held May 3, 2016, Respondent provided information demonstrating that corrective actions to address the violations had been implemented at the project site. A review of the information provided determined that the corrective actions taken appeared to be sufficient to return the project site to compliance with Mississippi's Large Construction Storm Water General Permit conditions.

2.

In lieu of a formal enforcement hearing concerning the violations listed above, Complainant and Respondent agree to settle this matter as follows:

A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$6,650. Respondent shall pay this penalty to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director. The settlement payment shall be submitted to:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

5.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. § 49-17-31, and that it has made an informed waiver
