AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality ("Commission"), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality ("MDEQ"), Complainant, and DuPont DeLisle Facility ("DuPont"), Respondent, in the above captioned cause, and agree as follows:

1.

MDEQ issued Prevention of Significant Deterioration (PSD) Permit to Construct No. 1020-00115 (the "Permit") on March 21, 2011 that included a 33.0 lb/hr Particulate Matter (PM) limit for combined filterable and condensable PM for Emission Point AJ-201. Respondent notified the Complainant in a letter dated April 19, 2011 that stack testing performed on March 1, 2011, prior to permit issuance, indicated that the source would likely not meet the emission limits proposed in the draft Permit. The Respondent conducted an additional stack test on May 3-4, 2011 that indicated PM emissions of 49.27 lb/hr, in excess of the applicable limit. On May 25, 2011, the Complainant notified the Respondent of the alleged violation for failure to meet the PM emission limit for AJ-201. Subsequent, to the second failed test, Respondent submitted a revised Permit application to modify the PM limit for AJ-201.

In lieu of a formal enforcement hearing concerning the alleged violation referenced above, Complainant and Respondent agree to settle this matter as follows:

Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$28,350.00. Respondent shall pay this penalty to Complainant within 45 days after this Agreed Order has been executed by the MDEQ Executive Director or her designee and shall submit the payment to the following address:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of the MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

5.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. Section 49-17-31 (Rev. 2003), and that it
