AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Delta Oil Mill, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated May 12, 2011, Respondent was contacted by Complainant and notified of the following violations at Respondent's facility located at 215 West River Road, Greenwood, Mississippi, in Leflore County:

- A. Failure to monitor for Total Ammonia Nitrogen since permit reissuance on August 9, 2010, in violation of Water - NPDES Permit No. MS0001317 effluent limitations and monitoring requirements
- B. Failure to monitor for Biochemical Oxygen Demand (5-Day) for the July through
 September 2010 quarterly reporting periods in violation of Water NPDES Permit
 No. MS0001317 effluent limitations and monitoring requirements

In a letter to Complainant dated May 18, 2011, Respondent alleged that all violations have been corrected. Subsequent quarterly discharge monitoring reports submitted by Respondent indicate that all parameters are being monitored and are within permitted effluent discharge limitations.

2.

In lieu of a formal enforcement hearing concerning the violations listed above. Complainant and Respondent agree to settle this matter as follows:

A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$12,000.00. Respondent shall pay this penalty to MDEO within fortyfive (45) days after execution of this Agreed Order by the MDEO Executive Director or her designee. Payment shall be submitted to the following address:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

5.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. Section 49-17-31 (Rev. 2003), and that it
