### AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Transcontinental Gas Pipe Line Company LLC, Station 77, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated April 3, 2017, Respondent was contacted by Complainant and notified of the following violation at its facility located at Highway 535 North, Seminary, Mississippi in Covington County:

A. Failure to comply with the Mississippi Air Pollution Control Title V Permit Condition 3.B.10 which states, "For Emission Point AA-021, the following emission limitations apply: ...CO 0.055 g/hp-hr, not to exceed 0.57 lb/hr and 2.51 tons/yr."

By notification letter dated November 30, 2016, Complainant was informed that Emission Point AA-021 exceeded the three-hour average pound per hour limit for carbon monoxide (CO) during the stack test conducted on October 3, 2016 required by the Title V permit. The actual emissions during the test were 1.30 lbs/hr for CO for a three-hour average. The catalyst bed for the

emission point was replaced and Emission Point AA-021 was re-tested on November 23, 2016. The results of the November 23, 2016 test confirmed the emission point had returned to compliance. The actual emission during the November 23, 2016 test were 0.0745 lbs/hr for CO for three-hour average.

2.

In lieu of a formal enforcement hearing concerning the violation listed above, Complainant and Respondent agree to settle this matter as follows:

A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$40,000.00. Respondent shall pay this penalty to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director or his designee. The settlement payment shall be submitted to:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

5.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. § 49-17-31, and that it has made an informed waiver

of that right.
