AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Precision Packaging, Inc., Respondent, in the above captioned cause and agree as follows:

1.

By letter dated July 3, 2019, Respondent was contacted by Complainant and notified of the following violations of Synthetic Minor Operating Permit (SMOP) No. 1080-00205 at its facility located at 2805 Meter Road, Jackson, Mississippi in Hinds County:

- A. SMOP No. 1080-00205, Condition T-2: Respondent failed to perform inspections and any required maintenance of the air pollution control equipment on a weekly basis.
- B. SMOP No. 1080-00205, Condition T-3: Respondent failed to provide documentation that it did not operate Emission Points AA-003, AA-010, and AA-012 more than 200 hours per year.
- C. SMOP No. 1080-00205, Condition T-4: Respondent failed to provide documentation that it did not operate Emission Points AA-001, AA-002, AA-005, AA-007, AA-011, AA-014, AA-017, AA-018, and AA-019 more than 4,160 hours per year.

D. SMOP No. 1080-00205, Condition T-23: Respondent failed to retain all required records, monitoring data, and supporting information for a period of at least five (5) years.

By letter dated July 19, 2019, Respondent asserts the facility has returned to compliance with SMOP No. 1080-00205.

In lieu of a formal enforcement hearing concerning the violations listed above, Complainant and Respondent agree to settle this matter as follows:

A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$52,500. Respondent shall pay this penalty to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director or his designee. The settlement payment shall be submitted to:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.
