AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Resinall Corp, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated August 24, 2023, Respondent was contacted by Complainant and notified of the following violations that were discovered during a Compliance Evaluation Inspection at Respondent's facility in Forrest County on September 22, 2022:

- A. Respondent installed a replacement Emergency Generator on June 30, 2021, prior to submitting a permit modification application in violation of Condition 1.A.3 of Synthetic Minor Operating Permit No. 0800-00009.
- B. Respondent failed to conduct an initial stack test within 180 days after initial startup of the Emergency Generator in violation of 40 CFR 60.4211(d).

On or about October 31, 2023, Respondent submitted an application for the modification of its Synthetic Minor Operating Permit to MDEQ. The application included the Emergency Generator that was installed on June 30, 2021.

On or about November 3, 2023, Respondent conducted an initial stack test on the Emergency Generator.

2.

In lieu of a formal enforcement hearing concerning the violations listed above, Complainant and Respondent agree to settle this matter as follows:

- A. Respondent agrees to pay, and Complainant agrees to accept a civil penalty in the amount of \$33,750.00. Respondent shall pay this penalty to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director or his designee. The settlement payment shall be submitted to:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

5.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. § 49-17-31, and that it has made an informed waiver of that right.
