AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Prairie Livestock Inc, Respondent, in the above captioned cause and agree as follows:

1.

By letters dated February 27, 2011, and July 7, 2011, Respondent was contacted by Complainant and notified of the following violations at Respondent's facility located at Barton Ferry Road, West Point, Mississippi in Clay County:

- A. Respondent failed to maintain records for the Production Area in violation of Water-NDDES Permit No. MS0048666 Condition R-1
- B. Respondent failed to submit timely renewal application in violation of Water-NPDES Permit No. MS0048666 Condition S-9

In a letter to Complainant dated May 3, 2011, Respondent alleged that it has designated an employee to be responsible for its compliance with the Water-NPDES Permit No.

MS0048666 and has retained contract services to provide compliance assistance. Respondent

submitted a renewal application on July 11, 2011.

In lieu of a formal enforcement hearing concerning the violations listed above, Complainant and Respondent agree to settle this matter as follows:

- A. Respondent agrees to operate its facility in accordance with the terms and conditions of Water-NPDES Permit No. MS0048666 until the Mississippi Environmental Quality Permit Board or its designee acts on the permit renewal application.
- B. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$15,000.00. Respondent shall pay this penalty to MDEQ within forty-five (45) days after execution of this Agreed Order by the MDEQ Executive Director or her designee (the "Effective Date"). Payment shall be submitted to the following address:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. Section 49-17-31 (Rev. 2003), and that it has made an informed waiver of that right.
