AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Resolute FP US Inc, Grenada Operations, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated November 7, 2012, Respondent was contacted by Complainant and notified of the following violation at its facility located at 1000 Papermill Road, Grenada, Mississippi in Grenada County:

- A. Failure to test within permitted limits for Particulate Matter (PM) emissions for the test conducted on the Bark Boiler on April 17, 2012. The Bark Boiler tested in compliance for PM emissions during a retest conducted on July 27, 2012. (*Air - Title V Operating Permit No. 0960-00015, Section 3.B.1*)

2.

In lieu of a formal enforcement hearing concerning the violation(s) listed above,

Complainant and Respondent agree to settle this matter as follows:

- A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$15,000.00. Respondent shall pay this penalty to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director. The settlement payment shall be submitted to:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.


