### **AGREED ORDER**

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Weyerhaeuser NR Company, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated February 20, 2013, Respondent was contacted by Complainant and notified of the following violations at its Philadelphia facility located at 1016 Weyerhaeuser Road, Philadelphia, Mississippi in Neshoba County:

- A. Failure to submit stack test reports in a timely manner. (TVOP, Section 5.B.2(2) & (6))
  - Stack test report for the No. 1 Wood Fired Boiler (AA-001) was due by
     October 28, 2012. Report was received by MDEQ on November 5, 2012.
  - Stack test report for the No. 2 Wood Fired Boiler (AA-002) was due by
     October 29, 2012. Report was received by MDEQ on November 5, 2012.

 2012. Report was received by MDEQ on December 26, 2012.

In lieu of a formal enforcement hearing concerning the violations listed above, Complainant and Respondent agree to settle this matter as follows:

A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$12,000.00. Respondent shall pay this penalty to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director. The settlement payment shall be submitted to:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

5.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing
