AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Huey Stockstill Inc, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated May 21, 2013, Respondent was contacted by Complainant and notified of the following violation(s) of the Ready-Mix Concrete General Permit MSG11052, located at 130 Huey Stockstill Road, Picayune, MS in Pearl River County:

- A. *Failure to treat and sample all process water outfalls (ACT 12:L-1).*
- B. *Failure to amend the SWPPP (ACT 14:S-1).*

Following the inspection, Respondent has conducted necessary adjustments onsite to return to compliance with Ready Mix Concrete General Permit No. MSG110052. In addition, Respondent has submitted an amendment to the Storm Water Pollution Prevention Plan for review. Complainant

has requested additional detail in the amendment.

2.

In lieu of a formal enforcement hearing concerning the violation(s) listed above, Complainant and Respondent agree to settle this matter as follows:

- A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$5,000.00. Respondent shall pay this penalty to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director, or her designee. The settlement payment shall be submitted to:

- B. Respondent agrees to submit an acceptable amendment to the Storm Water Pollution Prevention Plan no later than September 8, 2013.

3.

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

4.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.


5.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. Section 49-17-31 (Rev. 2003), and that it has made an

informed waiver of that right.
