Dear Ms. Rudolph:

Pursuant to the letter from the Mississippi Department of Environmental Quality (MDEQ), we understand that the general permit that authorizes the discharge of storm water associated with industrial activity has been reissued. The Industrial Stormwater General Permit for Industrial Activities (MSR00) was reissued on December 10, 2020, and replaces the previously titled Baseline Stormwater General Permit. Kenneth's Excavation Dirt and Gravel, Inc., dba Little Man's Landfill (Little Man's Landfill) is enclosing a completed *Industrial Stormwater General Permit Re-Coverage Form* in Attachment I and requests that an updated Certificate of Permit Coverage be issued.

Pursuant to Act 9, Condition S-1(4) of the *Industrial Storm Water General Permit For Industrial Activities*, the Storm Water Pollution Prevention Plan (SWPPP) for this facility has been updated and is provided in Attachment II for your review. The updates to this SWPPP include the new requirements for rubbish sites found in *Act 6 – Additional SWPPP Requirements for Rubbish Sites Accepting Industrial Waste* of the general permit.
