

Pursuant to the letter from the Mississippi Department of Environmental Quality (MDEQ) dated December 29, 2020, we understand that the general permit that authorizes the discharge of storm water associated with industrial activity has been reissued. The Industrial Stormwater General Permit for Industrial Activities (MSR00) was reissued on December 10, 2020, and replaces the previously titled Baseline Stormwater General Permit. Martinrea Automotive Structures (Martinrea) is enclosing a completed *Industrial Stormwater General Permit Re-Coverage Form* and requests that an updated Certificate of Permit Coverage be issued.
