

Pursuant to the letter from the Mississippi Department of Environmental Quality (MDEQ), we understand that the general permit that authorizes the discharge of storm water associated with industrial activity has been reissued. The Industrial Stormwater General Permit for Industrial Activities (MSR00) was reissued on December 10, 2020 and replaces the previously titled Baseline Stormwater General Permit. Vanleigh RV, Inc. (Vanleigh) is located at 338 Highway 72 East. Coverage No. MSR002313 is for the Cabinet Shop. Vanleigh is enclosing a completed Industrial Stormwater General Permit Re-Coverage Form and requests that an updated Certificate of Permit Coverage be issued.

Please note that we have updated the facility's Storm Water Pollution Prevention Plan (SWPPP) to reflect the new requirements of the General Permit. Per the instructions provided for re-coverage, we understand that these updates do not need to be submitted to MDEQ as long as the SWPPP is current and effective in controlling storm water pollutants.
