Upon approval, the permittee may discontinue monitoring for TTO, but the following certification statement must be made in the comment section of every discharge monitoring report submitted.</p> <p>"Based on my inquiry of the person or persons directly responsible for managing compliance with the permit limitations (or pretreatment standard) for total toxic organics (TTO), I certify that, to the best of my knowledge or belief, no dumping of concentrated toxic organics into the wastewater has occurred since filing of the last discharge monitoring report. I further certify that this facility is implementing the toxic organic management plan submitted to the permitting or control authority." [11 Miss. Admin. Code Pt. 6, R. 1.1.4.A.]</p>
