This notification applies to pollutants which are not subject to either effluent limitations in the permit or notification requirements under 40 CFR 122.42(a)(1). Proper operation and maintenance includes adequate laboratory controls and appropriate quality assurance procedures. T-13	<p>Bypassing- Prohibition of Bypass</p> <p>(1) Bypass is prohibited, and the Commission may take enforcement action against a permittee unless:</p> <p>(i) Bypass was unavoidable to prevent loss of life, personal injury, or sever property damage.</p> <p>(ii) There was no feasible alternatives to the bypass, such as the use of auxiliary treatment facilities, retention of untreated wastes, or maintenance during normal periods of equipment downtime.
