L-1		<p>In accordance with the Municipal and Domestic Water and Wastewater System Operator's Certification Act of 1986, this treatment unit must be operated by persons who are certified as qualified to operate the facility.</p> <p>Pump-out shall be performed only when the moisture condition of the soil is below field capacity and effluent shall be applied at rates that will prevent runoff of effluent. Effluent application shall not occur during rainfall, when heavy rainfall is predicted, or immediately thereafter.</p> <p>Stormwater runoff and all wastewater associated with the facility shall be managed in a manner to prevent a discharge to State waters.</p> <p>The lagoon and surrounding area shall be well maintained and free of trash and other debris. T-10	<p>Proper Operation, Maintenance and Replacement</p> <p>The permittee shall at all times properly operate, maintain, and when necessary, promptly replace all facilities and systems of collection, treatment and control (and related appurtenances) which are installed or used by the permittee to achieve compliance with the conditions of this permit. Proper operation and maintenance includes adequate laboratory controls and appropriate quality assurance procedures. Proper replacement includes maintaining an adequate inventory of replacement equipment and parts for prompt replacement when necessary to maintain continuous collection and treatment of wastewater.
