Industrial materials, residue or trash that may have or could come into contact with stormwater;</li><li>2. Leaks or spills from industrial equipment, drums, tanks and other containers;</li><li>3. Offsite tracking of industrial or waste materials, or sediment where vehicles enter or exit the site;</li><li>4. Tracking or blowing of raw, final or waste materials from areas of no exposure to exposed areas;</li><li>5. Control measures needing replacement, maintenance or repair.</li></ol> <p>During an inspection occurring during a stormwater event or discharge, control measures must be observed to ensure they are functioning correctly.
