### **APPENDIX A LIST OF ABBREVIATIONS USED IN THIS PERMIT**

## SECTION 1. GENERAL CONDITIONS

1.1 The permittee must comply with all conditions of this permit. Any permit non-compliance constitutes a violation of the Federal Act and is grounds for enforcement action; for permit termination, revocation and reissuance, or modification; or for denial of a permit renewal application.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(6)(a).)

1.2 It shall not be a defense for a permittee in an enforcement action that it would have been necessary to halt or reduce the permitted activity in order to maintain compliance with the conditions of this permit.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(6)(b).)

1.3 This permit and/or any part thereof may be modified, revoked, reopened, and reissued, or terminated for cause. The filing of a request by the permittee for a permit modification, revocation and reissuance, or termination, or of a notification of planned changes or anticipated noncompliance does not stay any permit condition.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(6)(c).)

1.4 Prior to its expiration, this permit may be reopened in accordance with the provisions listed below.

(a) This permit shall be reopened and revised under any of the following circumstances:

(1) Additional applicable requirements under the Federal Act become applicable to a major Title V source with a remaining permit term of three (3) or more years. Such a reopening shall be completed no later than eighteen (18) months after promulgation of the applicable requirement. No such reopening is required if the effective date of the requirement is later than the date on which the permit is due to expire, unless the original permit or any of its terms and conditions has been extended.

(2) Additional requirements (including excess emissions requirements) become applicable to an affected source under the acid rain program. Upon approval by the Administrator, excess emissions offset plans shall be deemed to be incorporated into the permit.

(3) The Permit Board or the EPA determines that the permit contains a material mistake or that inaccurate statements were made in establishing the emission standards or other terms or conditions of the permit.

(4) The Administrator or the Permit Board determines that the permit must be

revised or revoked to assure compliance with the applicable requirements.

- (b) Proceedings to reopen and issue this permit shall follow the same procedures as apply to initial permit issuance and shall only affect those parts of the permit for which cause to reopen exists. Such reopening shall be made as expeditiously as practicable.
- (c) Re-openings shall not be initiated before a notice of such intent is provided to the Title V source by the Mississippi Department of Environmental Quality (MDEQ) at least thirty (30) days in advance of the date that the permit is to be reopened, except that the Permit Board may provide a shorter time period in the case of an emergency.

- 1.5 The permittee shall furnish to the MDEQ within a reasonable time any information the MDEQ may request in writing to determine whether cause exists for modifying, revoking and reissuing, or terminating the permit or to determine compliance with the permit. Upon request, the permittee shall also furnish to the MDEQ copies of records required to be kept by the permittee or, for information to be confidential, the permittee shall furnish such records to the MDEQ along with a claim of confidentiality. The permittee may furnish such records directly to the Administrator along with a claim of confidentiality.

- 1.6 This permit does not convey any property rights of any sort, or any exclusive privilege.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(6)(d).)

- 1.7 The provisions of this permit are severable. If any provision of this permit or the application of any provision of this permit to any circumstances is challenged or held invalid, the validity of the remaining permit provisions and/or portions thereof or their application to other persons or sets of circumstances, shall not be affected thereby.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(5).)

- 1.8 The permittee shall pay to the MDEQ an annual permit fee. The amount of fee shall be determined each year based on the provisions of regulated pollutants for fee purposes and the fee schedule specified in the Commission on Environmental Quality's order, which shall be issued in accordance with the procedure outlined in Mississippi Administrative Code, Title 11, Part 2, Chapter 6 – “Air Emissions Operating Permit Regulations for Purposes of Title V of the Federal Clean Air Act”.

- (a) For purposes of fee assessment and collection, the permittee shall elect for actual or allowable emissions to be used in determining the annual quantity of emissions unless the Commission determines by order that the method chosen by the applicant

for calculating actual emissions fails to reasonably represent actual emissions. Actual emissions shall be calculated using emission monitoring data or direct emissions measurements for the pollutant(s); mass balance calculations such as the amounts of the pollutant(s) entering and leaving process equipment and where mass balance calculations can be supported by direct measurement of process parameters, such direct measurement data shall be supplied; published emission factors such as those relating release quantities to throughput or equipment type (e.g. air emission factors); or other approaches such as engineering calculations (e.g. estimating volatilization using published mathematical formulas) or best engineering judgments where such judgments are derived from process and/or emission data which supports the estimates of maximum actual emission.

- (b) If the Commission determines that there is not sufficient information available on a facility's emissions, the determination of the fee shall be based upon the permitted allowable emissions until such time as an adequate determination of actual emissions is made. Such determination may be made anytime within one year of the submittal of actual emissions data by the permittee.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.6.A.(2).)

- (c) If at any time within the year the Commission determines that the information submitted by the permittee on actual emissions is insufficient or incorrect, the permittee will be notified of the deficiencies and the adjusted fee schedule. Past due fees from the adjusted fee schedule will be paid on the next scheduled quarterly payment time.

- (d) The fee shall be due September 1 of each year. By July 1 of each year, the permittee shall submit an inventory of emissions for the previous year on which the fee is to be assessed. The permittee may elect a quarterly payment method of four (4) equal payments; notification of the election of quarterly payments must be made to the MDEQ by the first payment date of September 1. The permittee shall be liable for penalty as prescribed by State Law for failure to pay the fee or quarterly portion thereof by the date due.

- (e) If in disagreement with the calculation or applicability of the Title V permit fee, the permittee may petition the Commission in writing for a hearing in accordance with State Law. Any disputed portion of the fee for which a hearing has been requested will not incur any penalty or interest from and after the receipt by the Commission of the hearing petition.

- 1.9 No permit revision shall be required under any approved economic incentives, marketable permits, emissions trading and other similar programs or processes for changes that are provided for in this permit.

- 1.10 Any document required by this permit to be submitted to the MDEQ shall contain a certification by a responsible official that states that, based on information and belief formed after reasonable inquiry, the statements and information in the document are true, accurate, and complete.

- 1.11 The permittee shall allow the MDEQ, or an authorized representative, upon the presentation of credentials and other documents as may be required by law to perform the following:

- (a) Enter upon the permittee's premises where a Title V source is located, emissions-related activity is conducted, or where records must be kept under the conditions of this permit;
- (b) Have access to and copy, at reasonable times, any records that must be kept under the conditions of this permit;
- (c) Inspect at reasonable times any facilities, equipment (including monitoring and air pollution control equipment), practices, or operations regulated or required under the permit; and
- (d) As authorized by the Federal Act, sample or monitor, at reasonable times, substances or parameters for the purpose of assuring compliance with the permit or applicable requirements.

- 1.12 Except as otherwise specified or limited herein, the permittee shall have necessary sampling ports and ease of accessibility for any new air pollution control equipment, obtained after May 8, 1970, and vented to the atmosphere.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 1.3.I.(1).)

- 1.13 Except as otherwise specified or limited herein, the permittee shall provide the necessary sampling ports and ease of accessibility when deemed necessary by the Permit Board for air pollution control equipment that was in existence prior to May 8, 1970.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 1.3.I.(2).)

- 1.14 Compliance with the conditions of this permit shall be deemed compliance with any applicable requirements as of the date of permit issuance where such applicable requirements are included and are specifically identified in the permit or where the permit contains a determination, or summary thereof, by the Permit Board that requirements specifically identified previously are not applicable to the source.

- 1.15 Nothing in this permit shall alter or affect the following:
- (a) The provisions of Section 303 of the Federal Act (emergency orders), including the authority of the Administrator under that section;
  - (b) The liability of an owner or operator of a source for any violation of applicable requirements prior to or at the time of permit issuance;
  - (c) The applicable requirements of the acid rain program, consistent with Section 408(a) of the Federal Act.
  - (d) The ability of EPA to obtain information from a source pursuant to Section 114 of the Federal Act.

- 1.16 The permittee shall comply with the requirement to register a Risk Management Plan if permittee's facility is required pursuant to Section 112(r) of the Act to register such a plan.

- 1.17 Expiration of this permit terminates the permittee's right to operate unless a timely and complete renewal application has been submitted. A timely application is one which is submitted at least six (6) months prior to expiration of the Title V Operating Permit (TVOP). If the permittee submits a timely and complete application, the failure to have a TVOP is not a violation of regulations until the Permit Board takes final action on the permit application. This protection shall cease to apply if, subsequent to the completeness determination, the permittee fails to submit by the deadline specified in writing by the MDEQ any additional information identified as being needed to process the application.

- 1.18 The permittee is authorized to make changes within their facility without requiring a permit revision (ref: Section 502(b)(10) of the Act) if:

- (a) The changes are not modifications under any provision of Title I of the Act;
- (b) The changes do not exceed the emissions allowable under this permit;
- (c) The permittee provides the Administrator and the Department with written notification in advance of the proposed changes [at least seven (7) days, or such other timeframe as provided in other regulations for emergencies] and the notification includes the following:
  - (1) A brief description of the change(s);
  - (2) The date on which the change will occur;
  - (3) Any change in emissions; and
  - (4) Any permit term or condition that is no longer applicable as a result of the change.
- (d) The permit shield shall not apply to any Section 502(b)(10) change.

- 1.19 Should the Executive Director of the MDEQ declare an Air Pollution Emergency Episode, the permittee will be required to operate in accordance with the permittee's previously approved Emissions Reduction Schedule or, in the absence of an approved schedule, with the appropriate requirements specified in Mississippi Administrative Code, Title 11, Part 2, Chapter 3 – “Regulations for the Prevention of Air Pollution Emergency Episodes” – for the level of emergency declared.

- 1.20 Except as otherwise provided herein, a modification of the facility may require a Permit to Construct in accordance with the provisions of Mississippi Administrative Code, Title 11, Part 2, Chapter 2 – “Permit Regulations for the Construction and/or Operation of Air Emissions Equipment” – and may require modification of this permit in accordance with Mississippi Administrative Code, Title 11, Part 2, Chapter 6 – “Air Emissions Operating Permit Regulations for the Purposes of Title V of the Federal Clean Air Act”.

“Modification” is defined as [a]ny physical change in or change in the method of operation of a facility which increases the actual emissions or the potential uncontrolled emissions of any air pollutant subject to regulation under the Federal Act emitted into the atmosphere by that facility or which results in the emission of any air pollutant subject to regulation under the Federal Act into the atmosphere not previously emitted. A physical change or change in the method of operation shall not include:



- (a) Routine maintenance, repair, and replacement;
- (b) Use of an alternative fuel or raw material by reason of an order under Sections 2 (a) and (b) of the Federal Energy Supply and Environmental Coordination Act of 1974 (or any superseding legislation) or by reason of a natural gas curtailment plan pursuant to the Federal Power Act;
- (c) Use of an alternative fuel by reason of an order or rule under Section 125 of the Federal Act;
- (d) Use of an alternative fuel or raw material by a stationary source which:
  - (1) The source was capable of accommodating before January 6, 1975, unless such change would be prohibited under any federally enforceable permit condition which was established after January 6, 1975, pursuant to 40 CFR 52.21 or under regulations approved pursuant to 40 CFR 51, Subpart I (or 40 CFR 51.166); or
  - (2) The source is approved to use under any permit issued under 40 CFR 52.21 or under regulations approved pursuant to 40 CFR Part 51, Subpart I (or 40 CFR 51.166).
- (e) An increase in the hours of operation or in the production rate unless such change would be prohibited under any federally enforceable permit condition which was established after January 6, 1975, pursuant to 40 CFR 52.21 or under regulations approved pursuant to 40 CFR Part 51, Subpart I (or 40 CFR 51.166); or
- (f) Any change in ownership of the stationary source.

1.21 Any change in ownership or operational control must be approved by the Permit Board.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.4.D(4).)

1.22 This permit is a Federally-approved operating permit under Title V of the Federal Clean Air Act as amended in 1990. All terms and conditions, including any designed to limit the source's potential to emit, are enforceable by the Administrator and citizens under the Federal Act as well as the Commission.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.B.(1).)

1.23 Except as otherwise specified or limited herein, the open burning of residential, commercial, institutional, or industrial solid waste, is prohibited. This prohibition does not apply to infrequent burning of agricultural wastes in the field, silvi-cultural wastes for forest management purposes, land-clearing debris, debris from emergency clean-up

operations, and ordnance. Open burning of land-clearing debris must not use starter or auxiliary fuels which cause excessive smoke (rubber tires, plastics, etc.); must not be performed if prohibited by local ordinances; must not cause a traffic hazard; must not take place where there is a High Fire Danger Alert declared by the Mississippi Forestry Commission or an Emergency Air Pollution Episode Alert imposed by the Executive Director of the MDEQ and must meet the following buffer zones.

- (a) Open burning without a forced-draft air system must not occur within five hundred (500) yards of an occupied dwelling.
- (b) Open burning utilizing a forced-draft air system on all fires to improve the combustion rate and reduce smoke may be done within 500 yards of but not within fifty (50) yards of an occupied dwelling.
- (c) Burning must not occur within 500 yards of commercial airport property, private air fields, or marked off-runway aircraft approach corridors unless written approval to conduct burning is secured from the proper airport authority, owner or operator.

1.24 Except as otherwise specified herein, the permittee shall be subject to the following provision with respect to emergencies:

- (a) Except as otherwise specified herein, an “emergency” means any situation arising from sudden and reasonably unforeseeable events beyond the control of the source, including acts of God, which situation requires immediate corrective action to restore normal operation, and that causes the source to exceed a technology-based emission limitation under the permit, due to unavoidable increases in emissions attributable to the emergency. An emergency shall not include non-compliance to the extent caused by improperly designed equipment, lack of preventative maintenance, careless or improper operation, or operator error.
- (b) An emergency constitutes an affirmative defense to an action brought for noncompliance with such technology-based emission limitations if the conditions specified in Part (c) following are met.
- (c) The affirmative defense of emergency shall be demonstrated through properly signed contemporaneous operating logs, or other relevant evidence that include information as follows:
  - (1) An emergency occurred and that the permittee can identify the cause(s) of the emergency;
  - (2) The permitted facility was at the time being properly operated;
  - (3) During the period of the emergency the permittee took all reasonable steps to

minimize levels of emissions that exceeded the emission standards, or other requirements in the permit; and

- (4) The permittee submitted notice of the emergency to the MDEQ within two (2) working days of the time when emission limitations were exceeded due to the emergency. This notice must contain a description of the emergency, any steps taken to mitigate emissions, and corrective actions taken.
- (d) In any enforcement proceeding, the permittee seeking to establish the occurrence of an emergency has the burden of proof.
- (e) This provision is in addition to any emergency or upset provision contained in any applicable requirement specified elsewhere herein.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.G.)

1.25 Except as otherwise specified herein, the permittee shall be subject to the following provisions with respect to upsets, start-ups, and shutdowns.

- (a) Upsets (as defined in 11 Miss. Admin. Code Pt. 2, R. 1.2.)
  - (1) For an upset, the Commission may pursue an enforcement action for noncompliance with an emission standard or other requirement of an applicable rule, regulation, or permit. In determining whether to pursue enforcement action, and/or the appropriate enforcement action to take, the Commission may consider whether the source has demonstrated through properly signed contemporaneous operating logs or other relevant evidence the following:
    - (i) An upset occurred and that the source can identify the cause(s) of the upset;
    - (ii) The source was at the time being properly operated;
    - (iii) During the upset the source took all reasonable steps to minimize levels of emissions that exceeded the emission standard or other requirement of an applicable rule, regulation, or permit;
    - (iv) That within five (5) working days of the time the upset began, the source submitted a written report to the Department describing the upset, the steps taken to mitigate excess emissions or any other non-compliance, and the corrective actions taken and;
    - (v) That as soon as practicable but no later than twenty-four (24) hours of becoming aware of an upset that caused an immediate adverse impact to human health or the environment beyond the source boundary or

caused a general nuisance to the public, the source provided notification to the Department.

- (2) In any enforcement proceeding by the Commission, the source seeking to establish the occurrence of an upset has the burden of proof.
  - (3) This provision is in addition to any upset provision contained in any applicable requirement.
  - (4) These upset provisions apply only to enforcement actions by the Commission and are not intended to prohibit EPA or third party enforcement actions.
- (b) Start-ups and Shutdowns (as defined in 11 Miss. Admin. Code Pt. 2, R. 1.2.)
- (1) Start-ups and shutdowns are part of normal source operation. Emission limitations apply during start-ups and shutdowns unless source specific emission limitations or work practice standards for start-ups and shutdowns are defined by an applicable rule, regulation, or permit.
  - (2) Where the source is unable to comply with existing emission limitations established under the State Implementation Plan (SIP) and defined in this Mississippi Administrative Code, Title 11, Part 2, Chapter 1, the Department will consider establishing source specific emission limitations or work practice standards for start-ups and shutdowns. Source specific emission limitations or work practice standards established for start-ups and shutdowns are subject to the requirements prescribed in Mississippi Administrative Code, Title 11, Part 2, Chapter 1, Rule 1.10.B.(2)(a) through (e).
  - (3) Where an upset as defined in Rule 1.2 occurs during start-up or shutdown, see the upset requirements above.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 1.10.)

- 1.26 The permittee shall comply with all applicable standards for demolition and renovation activities pursuant to the requirements of 40 CFR Part 61, Subpart M, as adopted by reference in Mississippi Administrative Code, Title 11, Part 2, Chapter 1, Rule 1.8. The permittee shall not be required to obtain a modification of this permit in order to perform the referenced activities.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 1.8.)

- 1.27 Regarding compliance testing (if applicable):

- (a) The results of any emissions sampling and analysis shall be expressed both in units consistent with the standards set forth in any Applicable Rules and Regulations or this permit and in units of mass per time.

- (b) Compliance testing will be performed at the expense of the permittee.
- (c) Each emission sampling and analysis report shall include (but not be limited to) the following:
  - (1) Detailed description of testing procedures;
  - (2) Sample calculation(s);
  - (3) Results; and
  - (4) Comparison of results to all Applicable Rules and Regulations and to emission limitations in the permit.

### **SECTION 3. EMISSION LIMITATIONS & STANDARDS**

#### **A. FACILITY-WIDE EMISSION LIMITATIONS & STANDARDS**

3.A.1 Except as otherwise specified or limited herein, the permittee shall not cause or allow the emission of smoke from a point source into the open air from any manufacturing, industrial, commercial or waste disposal process that exceeds forty (40) percent opacity subject to the exceptions provided below:

- (a) Start-up operations may produce emissions that exceed 40% opacity for up to fifteen (15) minutes per start-up in any one (1) hour and not to exceed three (3) start-ups per stack in any twenty-four (24) hour period.
- (b) Emissions resulting from soot blowing operations shall be permitted provided such emissions do not exceed sixty (60) percent opacity and provided further that the aggregate duration of such emissions during any twenty-four (24) hour period does not exceed ten (10) minutes per billion BTU gross heating value of fuel in any one (1) hour.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 1.3.A.)

3.A.2 Except as otherwise specified or limited herein, the permittee shall not cause or allow the discharge into the ambient air from any point source any air contaminant of such opacity as to obscure an observer's view to a degree in excess of 40% opacity equivalent to that provided in Condition 3.A.1. This shall not apply to vision obscuration caused by uncombined water droplets.

3.A.3 The permittee shall not cause or allow the emission of particles or any contaminants in sufficient amounts or of such duration from any process as to be injurious to humans, animals, plants, or property, or to be a public nuisance, or create a condition of air pollution.

- (a) The permittee shall not cause or permit the handling, transporting, or storage of any material in a manner, which allows or may allow unnecessary amounts of particulate matter to become airborne.
- (b) When dust, fumes, gases, mist, odorous matter, vapors, or any combination thereof escape from a building or equipment in such a manner and amount as to cause a nuisance to property other than that from which it originated or to violate any other provision of 11 Miss. Admin. Code Pt. 2, Ch. 1, the Commission may order such corrected in a way that all air and gases or air and gas-borne material leaving the building or equipment are controlled or removed prior to discharge to the open air.

- 3.B.1 For Emission Point AA-000 (Facility-Wide), except as otherwise specified herein or limited herein, the permittee shall not cause or allow the emission of particulate matter (PM) in total quantities in any one (1) hour from any manufacturing process (which includes any associated stacks, vents, outlets, or combination thereof) to exceed the amount determined by the following relationship:

$$E = 4.1 \cdot (p^{0.67})$$

Where “E” is the emission rate in pounds per hour and “p” is the process weight input rate in tons per hour. Conveyor discharge of coarse solid matter may be allowed if no nuisance is created beyond the property boundary where the discharge occurs.

- 3.B.2 For Emission Point AA-001, except as otherwise specified herein, the maximum discharge of sulfur oxides shall not exceed 4.8 pounds (measured as sulfur dioxide or SO<sub>2</sub>) per million BTU (MMBTU) heat input from the boiler.

- 3.B.3 For Emission Point AA-001, except as otherwise specified herein, the permittee is allowed to emit filterable PM at a rate up to 0.30 grains per dry standard cubic foot (dscf) from the boiler.

- 3.B.4 For Emission Point AA-001, the permittee is subject to and shall comply with all applicable requirements found in 40 CFR Part 63, Subpart DDDDD – National Emission Standards for Hazardous Air Pollutants (NESHAP) for Major Sources for Industrial, Commercial, and Institutional Boilers and Process Heaters and 40 CFR Part 63, Subpart A – General Provisions (as required by Table 10 in Subpart DDDDD).

For the purpose of this permit, Emission Point AA-001 is considered an existing boiler in the “*hybrid suspension grate unit designed to burn biomass/bio-based solid*” subcategory.

- 3.B.5 For Emission Points AA-001, the permittee shall at all times operate and maintain each boiler (including associated air pollution control equipment and monitoring equipment) in a manner consistent with safety and good air pollution control practices for minimizing emissions.

The determination of whether such operation and maintenance procedures are being used will be based on information available to the MDEQ that may include (but is not limited to) monitoring results, review of operation and maintenance procedures, review of operation and maintenance records, and inspection of the source.

(Ref.: 40 CFR 63.7500(a)(3); Subpart DDDDD)

- 3.B.6 For Emission Point AA-001, except during periods of start-up and shutdown, the permittee shall at all times comply with the following emission limits:

- (a) Before October 6, 2025, the permittee **must** comply with the following emission limits:

- (1) Hydrogen Chloride (HCl): no more than 0.022 pounds per million BTU (MMBTU) of heat input **or** 0.025 pounds per MMBTU of steam output;
- (2) Mercury (Hg): no more than  $5.7 \times 10^{-06}$  pounds per MMBTU of heat input **or**  $6.4 \times 10^{-06}$  pounds per MMBTU of steam output;
- (3) Carbon Monoxide (CO): no more than 3,500 parts per million by volume on a dry basis (ppmvd) corrected to three (3) percent oxygen (based on a 3-run average) **or** 3.5 pounds per MMBTU of steam output (based on a 3-run average);
- (4) Filterable PM: no more than 0.44 pounds per MMBTU of heat input or 0.55 pounds per MMBTU of steam output [for Total Selected Metals (TSM): no more than 0.00045 pounds per MMBTU of heat input or 0.00057 pounds per MMBTU of steam output].

- (b) On and after October 6, 2025, the permittee **must** comply with the following emission limits:

- (1) Hydrogen Chloride (HCl): no more than 0.020 pounds per million BTU (MMBTU) of heat input **or** 0.023 pounds per MMBTU of steam output;
- (2) Mercury (Hg): no more than  $5.4 \times 10^{-06}$  pounds per MMBTU of heat input **or**  $6.2 \times 10^{-06}$  pounds per MMBTU of steam output;
- (3) Carbon Monoxide (CO): no more than 3,500 ppmvd corrected to three (3) percent oxygen (based on a 3-run average) **or** 3.5 pounds per MMBTU of steam output (based on a 3-run average);

- (4) Filterable PM: no more than 0.44 pounds per MMBTU of heat input or 0.55 pounds per MMBTU of steam output [for TSM: no more than 0.00045 pounds per MMBTU of heat input or 0.00057 pounds per MMBTU of steam output].

For the purpose of this permit, the permittee may comply with the emission limits specified in paragraph (b) of this condition prior to October 6, 2025.

3.B.7 For Emission Point AA-001, except during periods of start-up and shutdown, the permittee shall at all times comply with the following operating limits:

- (a) Operating Load: Maintain the rolling 30-day average operating load of a boiler such that it does not exceed 110% of the highest hourly average operating load recorded during the performance test conducted to demonstrate compliance with the emission limit(s) specified in Condition 3.B.6.
- (b) Oxygen Level: Operate the oxygen trim system on the boiler with the oxygen level set no lower than the lowest hourly average oxygen concentration measured during the performance test that demonstrates compliance with the CO emission limit specified in Condition 3.B.6(c).

3.B.8 For Emission Point AA-001, the permittee shall limit the total quantity of steam produced by the boiler to no more than 257,400,000.0 pounds per year based on a rolling 12-month total.

3.B.9 For Emission Points AA-011, AA-013, and AA-014, the permittee shall limit the total dried lumber production to more than the following limitation, based on a rolling 12-month total:

- (a) Emission Point AA-011: 66,000 MBF / year
- (b) Emission Point AA-013: 61,440 MBF / year
- (c) Emission Point AA-014: 87,560 MBF / year

3.B.10 For Emission Points AA-011, AA-013, and AA-014, the permittee is subject to and shall comply with all applicable requirements found in 40 CFR Part 63, Subpart DDDD –

NESHAP: Plywood and Composite Wood Products and 40 CFR Part 63, Subpart A – General Provisions (as required in Table 10 in Subpart DDDD).

(Ref.: 40 CFR 63.2231; Subpart DDDD)

- 3.B.11 For Emission Points AA-013 and AA-014, the permittee shall only combust uncontaminated wood residue as the primary fuel source. For the purpose of this permit, “uncontaminated wood residue” is as any by-product generated from processing harvested timber / dried lumber (i.e. sawdust, bark, wood chips, shavings, etc.) that does not possess an artificial coating. The permittee may purchase uncontaminated wood residue from third-party sources only if it meets the specified definition.

Additionally, the permittee is authorized to use diesel fuel to ignite a fuel bed during a start-up period.

- 3.B.12 For Emission Point AA-017, the permittee is subject to and shall comply with the applicable requirements found in 40 CFR Part 63, Subpart ZZZZ – National Emission Standards for Stationary Reciprocating Internal Combustion Engines (RICE) and 40 CFR Part 63, Subpart A – General Provisions (as required in Table 8 of Subpart ZZZZ).

For the purpose of this permit, stationary RICE is classified as “new” if construction or reconstruction commenced on / after June 12, 2006.

For new compression-ignition RICE, the permittee shall comply with the applicable requirements in Subpart ZZZZ by complying with 40 CFR Part 60, Subpart III – Standards of Performance for Stationary Compression Ignition (CI) Combustion Engines. No further requirements apply for such engines under Subpart ZZZZ.

(Ref.: 40 CFR 63.6585(a), (b), 63.6590(a)(2)(ii), and (c)(7); Subpart ZZZZ)

- 3.B.13 For Emission Point AA-017, the permittee is subject to and shall comply with all applicable requirements found in 40 CFR Part 60, Subpart III – Standards of Performance for Stationary Compression Ignition Internal Combustion Engines and 40 CFR Part 60, Subpart A – General Provisions (as required by Table 8 of Subpart III).

(Ref.: 40 CFR 60.4200(a)(2)(i); Subpart III)

- 3.B.14 For Emission Point AA-017, any operation of the engine for any reason other than emergency operation, maintenance and testing, and operation in non-emergency situations for fifty (50) hours per year is prohibited. If an engine is not operated in accordance with paragraphs (a) through (c) of this condition, the engine will not be considered an emergency engine under the applicable regulation and shall meet all requirements for a corresponding non-emergency engine.

- (a) There is no time limit on the use of an engine in emergency situations.
- (b) The permittee may operate an engine for the purpose of maintenance checks and readiness testing, provided that the tests are recommended by federal, state or local government, the manufacturer, the vendor, or the insurance company accompanied with the engine. Maintenance checks and readiness testing of an engine is limited to a maximum of one hundred (100) hours per calendar year. The permittee may petition the MDEQ for approval of additional hours to be used for maintenance checks and readiness testing. However, a petition is not required if the permittee maintains records indicating that Federal, State, or local standards require maintenance and testing of the engine beyond 100 hours per calendar year.
- (c) The permittee may operate an engine for up to 50 hours per calendar year in non-emergency situations. The 50 hours of operation in non-emergency situations are counted as part of the 100 hours per calendar year for maintenance and testing. The 50 hours per calendar year for non-emergency situations cannot be used for peak shaving or non-emergency demand response, or to generate income for a facility to supply power to an electric grid or otherwise supply power as part of a financial arrangement with another entity.

3.B.15 For Emission Point AA-017, the permittee shall only combust diesel fuel within the engine that meet the following requirements (on a per-gallon basis):

- (a) A maximum sulfur content of fifteen (15) parts per million (ppm); and
- (b) A minimum cetane index of forty (40) or a maximum aromatic content of thirty-five (35) volume percent.

3.B.16 For Emission Point AA-017, the permittee shall comply with the following emissions standards:

- (a) Non-Methane Hydrocarbons and Nitrogen Oxides (NMHC + NO<sub>x</sub>): 4.0 grams per kilowatt-hour (g / kW-hr)
- (b) Carbon Monoxide (CO): 5.0 grams per kilowatt-hour (g / kW-hr)
- (c) Particulate Matter (PM): 0.30 grams per kilowatt-hour (g / kW-hr)

The permittee shall operate and maintain the engine in such a manner as to achieve the emission standards over the entire life of each engine.

3.B.17 For Emission Point AA-017, the permittee shall not discharge into the atmosphere any smoke exhaust that exceeds the following opacity standards:

- (a) Twenty (20) percent during the acceleration mode;
- (b) Fifteen (15) percent during the lugging mode; and
- (c) Fifty (50) percent during the peaks in either acceleration or lugging modes.

The permittee shall operate and maintain the engine in such a manner as to achieve the referenced opacity standards over the entire life of the engine.

3.D.1 For Emission Points AA-001, the permittee must conduct a tune-up on the boiler every five (5) years and no more than sixty-one (61) months after the previous tune-up.

If a boiler is not operating on the required date for a tune-up, the tune-up must be conducted within thirty (30) calendar days of start-up. Additionally, a tune-up must be conducted while burning the type of fuel that provided the majority of the heat input to the boiler over the twelve (12) months prior to the tune-up.

Each tune-up shall be completed in accordance with the following specifications:

(a) As applicable, inspect the burner and clean (or replace) any components of the burner as necessary. The permittee may either perform the burner inspection any time prior to the required tune-up deadline or delay the burn inspection until the next scheduled unit shutdown. However, the permittee must inspect each burner at least once every seventy-two (72) months.

At units where entry into a piece of process equipment or into a storage vessel is required to complete a tune-up inspection, the inspection is required only during planned entries into the storage vessel or process equipment.

(b) As applicable, inspect the flame pattern and adjust the burner as necessary to optimize the flame pattern. The adjustment should be consistent with the manufacturer's specifications (if available).

(c) As applicable, inspect the system controlling the air-to-fuel ratio and ensure that it is correctly calibrated and functioning properly. The permittee may delay this inspection until the next scheduled unit shutdown.

- (d) Optimize total emission of CO. This optimization should be consistent with the manufacturer's specifications (if available) and with any NO<sub>x</sub> requirement to which the unit is subject;
- (e) Measure the concentrations in the effluent stream of CO in parts per million by volume (ppmv) and oxygen in volume percent (vol.%) before and after the adjustments are made (measurements may be either on a dry or wet basis as long as it is the same basis before and after the adjustments are made). Measurements may be taken using a portable CO analyzer.
- (f) Maintain on-site and submit (if requested by the MDEQ) a report containing the following information in paragraphs:
  - (1) The concentrations of CO in the effluent stream in ppmv and oxygen in vol.%, measured at high fire or the typical operating load, before and after the tune-up of a boiler;
  - (2) A description of any corrective actions taken as a part of the tune-up; and
  - (3) The type and amount of fuel used over the twelve (12) months prior to the tune-up, but only if the boiler was physically and legally capable of using more than one (1) type of fuel during that period. Units sharing a fuel meter may estimate the fuel used by each boiler.

(Ref.: 40 CFR 63.7500(a)(1), 63.7515(d), 63.7540(a)(10), (12) – (13), and Table 3 (Item 1); Subpart DDDDD)

3.D.2 For Emission Points AA-001, the permittee shall operate the boiler in accordance with the following requirements during periods of start-up and shutdown:

- (a) All continuous monitoring systems (CMS) must be operated during start-up and shutdown.
- (b) For start-up, the permittee must use one or a combination of the following clean fuels: natural gas; synthetic natural gas; propane; other “gas 1 fuels”; distillate oil; syngas; ultra-low sulfur diesel, fuel oil-soaked rags, kerosene, hydrogen, paper, cardboard, refinery gas; liquefied petroleum gas; clean dry biomass; and any fuels meeting the appropriate hydrogen chloride, mercury, and total suspended matter emission standards by fuel analysis.
- (c) The permittee shall comply with one (1) of the following work practice standard options:
  - (1) If the permittee chooses to comply using definition (1) of “*start-up*” found in Subpart DDDDD (once firing a fuel that is not clean fuel), the permittee must vent emissions to the main stack(s) and engage all of the applicable control devices. Start-up ends when any of the useful thermal energy from the boiler

or process heater is supplied for heating, and/or producing electricity, or for any other purpose.”

- (2) If the permittee chooses to comply using definition (2) of “*start-up*” found in Subpart DDDDD (once feeding a fuel that is not a clean fuel), the permittee must vent emissions to the main stack and engage all of the applicable control devices so as to comply with the emission limits within four (4) hours of the start of supplying useful thermal energy.

The permittee must engage and operate particulate matter (PM) control within one (1) hour of first feeding a fuel that is not a clean fuel. The permittee must start all applicable control devices as expeditiously as possible except in any case when necessary to comply with other standards applicable to the boiler by a permit limit or a rule other than Subpart DDDDD that requires operation of the control device(s).

The permittee must develop and implement a written “Start-Up and Shutdown Plan” in accordance with 40 CFR 63.7505(e), Subpart DDDDD.

- (d) While firing a fuel that is not a clean fuel during shutdown, the permittee must vent emissions to the main stack(s) and operate all applicable control devices. If another fuel must be used to support the shutdown process (in addition to the fuel used prior to the initiation of shutdown), the additional fuel must be one or a combination of the following clean fuels: natural gas; synthetic natural gas; propane; other “gas 1 fuels”; distillate oil; syngas; ultra-low sulfur diesel; refinery gas; and liquefied petroleum gas.
- (e) The permittee must comply with all applicable emission limits at all times except for start-up or shutdown periods that conform to the work practices specified in this condition.

(Ref.: 40 CFR 63.7500(f), 63.7540(d), 63.7555, and Table 3 (Items 5 and 6); Subpart DDDDD)

3.D.3 For Emission Point AA-017, the permittee shall demonstrate compliance with the emission standards outlined in Conditions 3.B.15 and 3.B.16 by performing the following work practices:

- (a) Operate and maintain each engine and control device (if any) according to the manufacturer's emission-related written instructions;
- (b) Change only those emissions-related settings that are permitted by the manufacturer; and
- (c) Meet the requirements of 40 CFR Part 1068 (as applicable).

(Ref.: 40 CFR 60.4211(a); Subpart IIII)

## **SECTION 4. COMPLIANCE SCHEDULE**

- 4.1 Unless otherwise specified herein, the permittee shall be in compliance with all requirements contained herein upon issuance of this permit.
- 4.2 Except as otherwise specified herein, the permittee shall submit to the Permit Board and to the Administrator of EPA Region IV a certification of compliance with permit terms and conditions (including emission limitations, standards, or work practices) by January 31 of each year for the preceding calendar year. If the permit was reissued or modified during the course of the preceding calendar year, the certification of compliance shall address each version of the permit. Each compliance certification shall include the following items:
- (a) The identification of each term or condition of the permit that is the basis of the certification;
  - (b) The compliance status;
  - (c) Whether compliance was continuous or intermittent;
  - (d) The method(s) used for determining the compliance status of the source, currently and over the applicable reporting period;
  - (e) Such other facts as may be specified as pertinent in specific conditions elsewhere in this permit.

## **SECTION 5. MONITORING, RECORDKEEPING & REPORTING REQUIREMENTS**

### **A. GENERAL MONITORING, RECORDKEEPING AND REPORTING REQUIREMENTS**

5.A.1 The permittee shall install, maintain, and operate equipment and/or institute procedures as necessary to perform the monitoring and recordkeeping specified below.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(3).)

5.A.2 In addition to the recordkeeping specified below, the permittee shall include with all records of required monitoring information the following:

- (a) The date, place as defined in the permit, and time of sampling or measurements;
- (b) The date(s) analyses were performed;
- (c) The company or entity that performed the analyses;
- (d) The analytical techniques or methods used;
- (e) The results of such analyses; and
- (f) The operating conditions existing at the time of sampling or measurement.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(3)(b)(1).)

5.A.3 Except where a longer duration is specified in an applicable requirement, the permittee shall retain records of all required monitoring data and support information for a period of at least five (5) years from the date of the monitoring sample, measurement, report, or application. Supporting information includes all calibration and maintenance records, all original strip-chart recordings for continuous monitoring instrumentation, and copies of all reports required by the permit.

5.A.4 Except as otherwise specified herein, the permittee shall submit reports of any required monitoring by July 31 and January 31 of each calendar year for the preceding six-month period. All instances of deviations from permit requirements must be clearly identified in such reports and all required reports must be certified by a responsible official consistent with Mississippi Administrative Code, Title 11, Part 2, Chapter 6, Rule 6.2.E.

For applicable periodic reporting requirements in 40 CFR Parts 60, 61, and 63, the permittee shall comply with the deadlines in this condition for reporting conducted on a semiannual basis. Additionally, any required quarterly reports shall be submitted by the end of the month following each calendar quarter (i.e. April 30, July 31, October 31, and January 31) and any required annual reports shall be submitted by January 31 following

each calendar year.

- 5.A.5 Except as otherwise specified herein, the permittee shall report all deviations from permit requirements, including those attributable to upsets, the probable cause of such deviations, and any corrective actions or preventive measures taken. The report shall be made within five (5) working days of the time the deviation began.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(3)(c)(2).)

- 5.A.6 Except as otherwise specified herein, the permittee shall perform emissions sampling and analysis in accordance with EPA Test Methods and with any continuous emission monitoring requirements, if applicable. All test methods shall be those versions or their equivalents approved by the MDEQ and the EPA.

- 5.A.7 The permittee shall maintain records of any alterations, additions, or changes in equipment or operation.

- 5.A.8 Unless otherwise specified in Section 4, upon permit issuance, the monitoring, testing, recordkeeping, and reporting requirements of Section 5 herein supersede the requirements of any preceding permit to construct and/or operate.

- 5.B.1 For Emission Point AA-000 (Facility-Wide), the permittee shall monitor the emission increase of volatile organic compounds (VOCs) as a result of the construction project authorized in the Permit to Construct Air Emissions Equipment issued June 21, 2016.

The permittee shall calculate and maintain the respective emission in tons per year (tpy) on a 12-month calendar year basis from all sources affected by the construction project for a duration of ten (10) years following resumption of regular operations after the permitted modifications in accordance with 40 CFR 52.21(r)(6)(i)(c); Subpart A.

(Ref.: 40 CFR 52.21(r)(6)(iii); Subpart A.)

- 5.B.2 For Emission Points AA-001, AA-007, AA-008, AA-009, and AA-016, the permittee shall perform a visible emissions observation in accordance with EPA Test Method 22 on the exhaust from the units during daylight hours and during representative operating conditions on a weekly basis. Each observation shall be conducted for a minimum period of six (6) consecutive minutes.

If visible emissions are detected during an observation which appear to be in excess of the applicable state regulation, the permittee shall perform and record a visible emission evaluation (VEE) in accordance with EPA Test Method 9. In the event that a VEE is required but cannot be conducted, the permittee shall record a written explanation as to why it was not possible to perform the VEE.

The permittee shall maintain documentation that details the information specified by Method 22 and/or Method 9, the date and time of each observation / evaluation, the results of each observation / evaluation, and any corrective actions taken to prevent or



minimize emissions.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(3)(a)(2).)

- 5.B.3 For Emission Point AA-001, the permittee shall monitor and record the total amount of steam produced on both a monthly and rolling 12-month total basis.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(3)(a)(2).)

- 5.B.4 For Emission Point AA-001, the permittee shall demonstrate compliance with the emission limits specified in Condition 3.B.6 in accordance with one of the following methods (as applicable):

(a) Performance Testing:

- (1) Unless otherwise specified herein, the permittee shall conduct performance testing on an annual basis and not to exceed thirteen (13) months after the previously completed test.
- (2) The permittee shall conduct each test in accordance with the following requirements:
  - (i) All performance testing shall be performed in accordance with the applicable requirements specified in 40 CFR 63.7520 and Table 5, Subpart DDDDD and at representative load conditions.
  - (ii) A performance test shall be conducted at representative operating load conditions while burning the type of fuel or mixture of fuels that has the highest content of chlorine and mercury. Upon request, the permittee shall make available to the MDEQ such records as may be necessary to determine the conditions of a performance test.
  - (iii) During each performance test, the permittee shall establish the operating limits specified in Condition 3.B.7 in accordance with Table 7 in Subpart DDDDD and any conduct CMS performance evaluation in accordance with 40 CFR 63.7525, Subpart DDDDD.
- (3) If a performance test for a given pollutant specified by Condition 3.B.6 (i.e. PM [or TSM], CO, HCl, and Hg) are at or below 75% of the corresponding emission limit for at least two (2) consecutive years **and** there have been no changes to the operation of the boiler or air pollution control equipment that could increase emissions, the permittee may choose to conduct subsequent performance tests for the pollutant once every three (3) years (not to exceed thirty-seven (37) months after the previously completed test).

If a performance test results for a specific pollutant indicates that the emissions are in excess of 75% of the corresponding emission limitation, the permittee must resume testing on an annual basis until such time the

performance tests over a two-year period fall below 75% of the emission limit.

(b) Fuel Analysis:

- (1) The permittee may demonstrate compliance with the Hg, HCl, or TSM emission limit specified in Condition 3.B.6 by conducting a fuel analysis in accordance with 40 CFR 63.7521 and Table 6 in Subpart DDDDD.
- (2) Unless otherwise specified herein, the permittee shall conduct a fuel analysis on a monthly basis. The permittee may comply with this monthly requirement by completing the fuel analysis any time within the calendar month as long as the analysis is separated from the previous analysis by at least fourteen (14) calendar days.
- (3) If each of twelve (12) consecutive monthly fuel analyses demonstrates a compliance level at or below 75%, the permittee may decrease the fuel analysis frequency from monthly to quarterly.

However, if any quarterly analysis exceeds 75% of the compliance level or the permittee begins combusting a new type of fuel, the permittee shall return to a monthly fuel analysis frequency for that fuel until twelve (12) months of fuel analyses are again less than 75% of the compliance level.

If the permittee conducts sampling on one (1) day per month, the permittee shall sample no less than fourteen (14) days apart. However, if multiple samples are taken per month, the 14-day restriction does not apply

(Ref.: 40 CFR 63.7505(c), 63.7515(a) – (c), (e), and 63.7520(b) – (f), and 63.7521; Subpart DDDDD)

- 5.B.5 For Emission Point AA-001, the permittee shall maintain a site-specific monitoring plan in accordance with the requirements in 40 CFR 63.7505(d)(1) – (4), Subpart DDDDD for the use of continuous parameter monitoring system (CPMS) or continuous emissions monitoring system (CEMS).

Additionally, the permittee shall maintain a site-specific stack test plan in accordance with 40 CFR 63.7(c), Subpart A that includes a test program summary, a test schedule, data quality objectives, and both an internal and external quality assurance program. The data quality objectives are the pretest expectations of precision, accuracy, and completeness of data.

(Ref.: 40 CFR 63.7505(d) and 63.7520(a); Subpart DDDDD)

- 5.B.6 For Emission Point AA-001, the permittee shall operate and maintain each continuous monitoring system (CMS) in accordance with the site-specific monitoring plan required by Condition 5.B.5 and the following procedures:

- (a) The CMS must complete a minimum of one (1) cycle of operation every fifteen (15) minutes and have a minimum of four (4) successive cycles of operation to have a valid hour of data. Any 15-minute period for which a CMS is out-of-control and data are not available for a required calculation constitutes a deviation from the monitoring requirements.

Other situations that constitute a monitoring deviation are specified in paragraph (d) of this condition.

- (b) The permittee shall operate monitoring systems and collect data at all required intervals at all times that the boiler is operating and compliance is required, except for periods of monitoring system malfunctions or out-of-control periods, and required monitoring system quality assurance or control activities, including (as applicable) calibration checks, required zero and span adjustments, and scheduled CMS maintenance as defined in the site-specific monitoring plan.

A monitoring system malfunction is any sudden, infrequent, not reasonably preventable failure of the monitoring system to provide valid data. Monitoring system failures that are caused in part by poor maintenance or careless operation are not malfunctions. The permittee is required to complete monitoring system repairs in response to monitoring system malfunctions or out-of-control periods and to return the monitoring system to operation as expeditiously as practicable.

- (c) The permittee may not use data recorded during periods of start-up and shutdown, monitoring system malfunctions or out-of-control periods, repairs associated with monitoring system malfunctions or out-of-control periods, or required monitoring system quality assurance or control activities in data averages and calculations used to report emissions or operating levels.

The permittee shall record and make available upon request the results of CMS performance audits and the date and duration of periods when the CMS is out-of-control to completion of the corrective actions necessary to return the CMS to operation consistent with the site-specific monitoring plan. The permittee must use all data collected during all other periods in assessing compliance and the operation of the control device and associated control system.

- (d) Except during periods of monitoring system malfunctions, repairs associated with monitoring system malfunctions, and required monitoring system quality assurance or quality control activities, the failure to collect required data is a deviation of the monitoring requirements.

In calculating monitoring results, the permittee shall not use any data collected during periods of start-up and shutdown, when the monitoring system is out-of-control as specified in the site-specific monitoring plan, while conducting repairs associated with periods when the monitoring system is out-of-control, or while conducting required monitoring system quality assurance or quality control activities. The permittee must calculate monitoring results using all other

monitoring data collected while the boiler is in operation.

- (e) For the operating load, the permittee must determine the rolling 30-day average from all recorded readings, except as allowed in paragraph (c) of this condition.
- (f) The permittee shall record and maintain the results of each inspection, calibration, and/or validation check performed on a CMS.

(Ref.: 40 CFR 63.7525(d) and 63.7535; Subpart DDDDD)

- 5.B.7 For Emission Point AA-001, the permittee must install, operate, and maintain an oxygen analyzer system in accordance with the manufacturer's recommendations. Additionally, the permittee shall maintain documentation that details the manufacturer's recommendations for the system(s).

(Ref.: 40 CFR 63.7525(a); Subpart DDDDD)

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(3)(a)(2).)

- 5.B.8 For Emission Point AA-001, the permittee shall demonstrate continuous compliance with the CO emission limit specified in Condition 3.B.6(c) by establishing a unit-specific limit for the minimum oxygen level.

The minimum oxygen level shall be set at the lower of the minimum values established during the applicable performance test runs by collecting oxygen data every fifteen (15) minutes during the entire period of the performance test. The permittee shall determine the hourly average oxygen concentration by computing the hourly averages using all of the 15-minute readings taken during each performance test run and determine the lowest hourly average established during the performance test as the minimum operating limit.

(Ref.: 40 CFR 63.7525(a), 63.7530(b)(4)(viii), and Table 7 (Item 4); Subpart DDDDD)

- 5.B.9 For Emission Point AA-001, the permittee shall demonstrate continuous compliance with all emission limits specified in Condition 3.B.6 by establishing the maximum operating load to be monitored by the heat input monitor or steam generation monitor.

The permittee must establish the maximum operating load by conducting a performance test required by Condition 5.B.4 at representative operating load conditions while burning the type of fuel (or mixture of fuels) that has the highest content of chlorine, mercury, and TSM (if opting to comply with the TSM alternative standard).

The permittee shall collect either heat input or steam generation data every fifteen (15) minutes during the entire period of a performance test, determine the hourly average heat input or steam generation rate by computing the hourly averages using all of the 15-minute readings taken during a performance test, and determine the highest hourly average established during the performance test. The resulting operating limit shall be established by multiplying the highest hourly average by 1.1 (i.e. 110 percent).

(Ref.: 40 CFR 63.7520(c) and Table 7 (Item 5); Subpart DDDDD)

5.B.10 For Emission Points AA-001, the permittee shall demonstrate continuous compliance with the operating load limit specified in Condition 3.B.7(a) in accordance with the following methods (as applicable):

- (a) Collect either the heat input data or steam generation data every fifteen (15) minutes.

Reduce the data to a rolling 30-day average and maintain the rolling 30-day average heat input or steam generation rate such that it does not exceed 110% of the highest hourly average heat input or steam generation rate recorded during the most recent performance test required by Condition 5.B.4.

- (b) Operation above the established maximum operating limit is a deviation except during a performance test conducted either to determine compliance with an applicable emission limit or to establish a new operating limit. The operating limit must be confirmed and/or reestablished during each performance test.
- (c) Maintain records on the type and amount of all fuels burned in the boiler to demonstrate that all fuel types and mixtures of fuels burned would result in equal to or lower fuel input of chlorine, mercury, and total selected metals (TSM) than the maximum values calculated during the last performance test.

(Ref.: 40 CFR 63.7540(2)(ii) and Table 8 (Item 10); Subpart DDDDD)

5.B.11 For Emission Points AA-001, the permittee shall maintain the following information (as applicable):

- (a) A copy of each notification and report submitted to comply with Subpart DDDDD, (including all documentation supporting an Notification of Compliance Status or a submitted semi-annual compliance report);
- (b) Records on all performance tests, other compliance demonstrations, and performance evaluations;
- (c) For each CMS or CEMS, the permittee shall maintain the following information (as applicable):
  - (1) Records described in 40 CFR 63.10(b)(2)(vii) – (xi), Subpart A;
  - (2) Previous versions of the performance evaluation plan as required by 40 CFR 63.8(d)(3), Subpart A;
  - (3) Any request for an alternative to the relative accuracy test for CEMS as required in 40 CFR 63.8(f)(6)(i), Subpart A; and
  - (4) Records on the date and time each deviation started and stopped.

- (d) Records required by Condition 5.B.10, including documentation on all monitoring data and calculated averages for the operating load to demonstrate continuous compliance with each applicable emission limit and/or operating limit;
- (e) The quantity of each fuel type combusted in the boiler on a monthly basis;
- (f) A copy of all calculations and supporting documentation for the maximum chlorine fuel input, maximum mercury fuel input (as specified in 40 CFR 63.7530, Subpart DDDDD) that were done to demonstrate continuous compliance with the applicable emission limit. Supporting documentation should include the basis for the estimates of maximum chlorine, mercury, and TSM fuel input;
- (g) If the permittee chooses to conduct performance testing less frequently than on an annual basis, the permittee shall maintain records that both demonstrate the results from the previous stack tests were less than 75% of the applicable emission limit(s) and indicates that there was no change in source operations (including fuel composition and operation of the air pollution control equipment that would cause emissions of the relevant pollutant to increase within the past year);
- (h) Records on the occurrence and duration of each malfunction of either the boiler or the associated air pollution control and/or monitoring equipment;
- (i) Records on the actions taken during periods of malfunction to minimize emissions in accordance with Condition 3.B.6 to minimize emissions (including corrective actions to restore the malfunctioning boiler, air pollution control or monitoring equipment to its normal use or usual manner of operation);
- (j) Records on the calendar date, time, occurrence, and duration of each start-up and shutdown;
- (k) Records on the type(s) and amount(s) of fuel used during each start-up and shutdown period;
- (l) For each start-up period conducted in accordance with definition (2) of “*start-up*” (as defined in 40 CFR 63.7575, Subpart DDDDD), the permittee shall maintain the following information:
  - (1) Records on the start time for the combustion of fuels not considered “clean fuels” and the time in which useful thermal energy is first supplied; and
  - (2) Records on the hourly steam temperature, hourly steam pressure, hourly steam flow, and hourly flue gas temperature.

(Ref.: 40 CFR 63.7555(a) – (c) and (d)(1) – (12); Subpart DDDDD)

5.B.12 For Emission Points AA-007, AA-008, AA-009, AA-015, and AA-016, the permittee shall perform an inspection that evaluates the performance capability of each cyclone once every month. If a problem is noted during the inspection of a cyclone, the permittee

shall perform the necessary maintenance to ensure operation as originally designed. Additionally, the permittee shall maintain on-site (to the extent practicable) sufficient components as is necessary to repair a cyclone.

The permittee shall maintain documentation that details the date / time of each inspection, the results of each inspection, any problem that is detected, any maintenance (either corrective or preventative) performed to return a cyclone to operation as originally designed, and the duration in which a cyclone is non-operational due to malfunction.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A. (3)(a)(2).)

- 5.B.13 For Emission Points AA-011, AA-013, and AA-014, the permittee shall monitor and record the individual production of dried lumber from each kiln in board feet on both a monthly and rolling 12-month total basis.

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A. (3)(a)(2).)

- 5.B.14 For Emission Point AA-017, the permittee shall monitor and record (via a non-resettable hour meter) the hours of operation for each engine about emergency and non-emergency service on a monthly basis. Additionally, the permittee shall maintain documentation that details what classified each occurrence as either an “emergency” or “non-emergency”.

(Ref.: 40 CFR 60.4214(b); Subpart III)

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(3)(a)(2).)

- 5.B.15 For Emission Point AA-017, the permittee shall maintain documentation that details the following information:

- (a) All notifications submitted to comply with Subpart III;
- (b) Any maintenance conducted on an engine; and
- (c) Documentation from the manufacturer that indicate an engine is certified to meet the emission standards specified in Conditions 3.B.15, 3.B.16, and 3.B.17.

(Ref.: 40 CFR 60.4214(a)(2); Subpart III)

- 5.B.16 For Emission Points AA-017, the permittee shall demonstrate compliance through with the emission standards specified in Condition 3.B.15 through the following actions **if** the permittee does not operate and maintain the engine according to the manufacturer’s emission-related written instructions or the permittee changes emission-related settings in a way that is not permitted by the manufacturer:

- (a) Keep a maintenance plan, records of conducted maintenance, and (to the extent practicable) maintain and operate the engine in a manner consistent with good air pollution control practice for minimizing emissions; and

- (b) The permittee shall conduct an initial performance test in accordance with the procedures outlined in 40 CFR 60.4212(a) – (c); Subpart IIII (as applicable) to demonstrate compliance with the applicable emission standards in accordance within one of the following deadlines:
- (1) Within one (1) year of start-up,
  - (2) Within one (1) year after the engine is no longer installed, configured, operated, and maintained in accordance with the manufacturer's emission-related written instructions, or
  - (3) Within one (1) year after the permittee changes emission-related settings in a way that is not permitted by the manufacturer.

5.C.1 For Emission Point AA-000 (Facility-Wide), the permittee shall submit an annual report to the MDEQ no later than March 1 (or February 29 – when applicable) of each year for the preceding 12-month calendar year that contains the information specified in paragraphs (a) – (c) of this condition **if** the calculated annual emissions required by Condition 5.B.1 either exceed the baseline actual emissions documented for PM, PM<sub>10</sub> (filterable + condensable) and/or PM<sub>2.5</sub> (filterable + condensable) in the pre-construction PSD major modification applicability test by a “significant” amount [as defined in 40 CFR 52.21(b)(23); Subpart A] or differ from the established pre-construction projected emission presented in the permit application received on July 24, 2020.

- (a) The name, address, and telephone number of the facility;

- (b) The calculated annual emissions as specified in Condition 5.B.1; and
- (c) Any other information that the permittee wishes to include in the report (e.g. an explanation as to why the emissions differ from the established pre-construction projections).

5.C.2 For Emission Point AA-000 (Facility-Wide), the permittee shall submit a semi-annual monitoring report (SMR) in accordance with Condition 5.A.4 to the MDEQ that contains the following information:

- (a) For Emission Point AA-001 – the total steam production in pounds on both a monthly and rolling 12-month total basis.
- (b) For Emission Points AA-011, AA-013, and AA-014 – the total throughput (in board feet) of lumber dried within all kilns on both a monthly and 12-month rolling total basis; and
- (c) For Emission Point AA-017 – the hours of operation for the emergency engine (including a summary on how many hours are spent for emergency operation, what classified the operation as an emergency situation, how many hours are spent for non-emergency operation, and the circumstances for non-emergency operation).

(Ref.: 11 Miss. Admin. Code Pt. 2, R. 6.3.A.(3)(c)(1).)

5.C.3 For Emission Point AA-001, the permittee shall submit a semi-annual compliance report in accordance with Condition 5.A.4 to the MDEQ and the EPA that contains the following information:

- (a) The date of the most recent tune-up (including the date of the most recent burner inspection if it was not completed on an 5-year basis and was delayed until the next scheduled or unscheduled unit shutdown);
- (b) For each CMS (including a CPMS) – the monitoring equipment manufacturer(s), the model number(s), and the date of the last CMS certification or audit;
- (c) The total fuel use by a boiler – including (but not limited to) a description of the fuel, whether the fuel has received a non-waste determination by the EPA or the permittee's basis for concluding the fuel is not a waste, and the total fuel usage amount with units of measure;
- (d) If the permittee is conducting a performance test once every three (3) years, as allowed in Condition 5.B.4(c), the date of the last two (2) performance tests and a statement as to whether there have been any operational changes since the last performance test that could increase emissions;
- (e) A statement indicating that no new types of fuel were burned in a boiler. If a new

type of fuel was burned, the permittee shall submit the required HCl, Hg, and TSM information in accordance with 40 CFR 63.7550(c)(5)(viii), Subpart DDDDD;

- (f) If the permittee intends to burn a new type of fuel that is non-compliant with the maximum chlorine, mercury, or TSM input operating limit(s), the permittee shall include a statement indicating the intent to conduct a new performance test no later than sixty (60) days after starting to burn the new fuel;
- (g) A summary of any monthly fuel analyses conducted to demonstrate compliance with the HCl, Hg, or TSM emission limit specified in Condition 3.B.6 in accordance with 40 CFR 63.7521, Subpart DDDDD;
- (h) If there are no deviations from an applicable emission limit or operating limit, include a statement that there were no deviations from the emission limits or operating limits during the reporting period;
- (i) If there were no deviations from monitoring requirements (including no periods during which a CMS was out of control), include a statement that there were no deviations and no periods during which the monitoring system(s) was out of control during the reporting period;
- (j) If a malfunction occurred during the reporting period, the report shall include the number, duration, and a brief description for each type of malfunction which occurred during the reporting period and which caused / may have caused any applicable emission limitation to be exceeded;
- (k) For each instance of start-up or shutdown, include the information required to be monitored, collected, or recorded as required by Condition 5.B.11(j) through (l);
- (l) If there is a deviation from an emission limit, operating limit, or work practice standard for periods of start-up and shutdown where a CMS **is not** used to demonstrate compliance, the compliance report shall also contain the following information:
  - (1) A description of the deviation and for which emission limit, operating limit, or work practice standard it occurred;
  - (2) Information on the number, duration, and cause of deviations (including any unknown cause, as applicable), and the corrective action taken; and
  - (3) If the deviation occurred during an annual performance test, the date in which the annual performance test was completed.
- (m) If there is a deviation from an emission limit, operating limit, or monitoring requirement where a CMS **is** used to demonstrate compliance, the compliance report shall also contain the following information:
  - (1) The date and time each deviation started and stopped and description of the

nature of the deviation;

- (2) The date and time that each CMS was inoperative, except for zero (low-level) and high-level checks;
- (3) The date, time, and duration that each CMS was out of control (including the information specified in 40 CFR 63.8(c)(8), Subpart A);
- (4) A summary of the total duration of the deviation during a reporting period and the total duration as a percent of the total source operating time during that reporting period;
- (5) A characterization of the total duration of the deviations during a reporting period into those that are due to control equipment problems, process problems, other known causes, and other unknown causes;
- (6) A summary of the total downtime duration for the CMS during a reporting period and the total duration of the CMS downtime as a percent of the total source operating time during that reporting period;
- (7) A brief description of the source for which there was a deviation; and
- (8) A description of any changes in the CMS, the processes, or controls since the last reporting period for the source for which there was a deviation.

- 5.C.4 For Emission Point AA-001, the permittee shall submit a notification of intent to conduct any performance test required by Condition 5.B.4 to the MDEQ at least sixty (60) days before the performance test is scheduled to begin.

- 5.C.5 For Emission Point AA-001, the permittee shall submit a report that contains the results from any performance test required by Condition 5.B.4 to the MDEQ and the EPA no later than sixty (60) days after completing the actual test.

The report shall either verify that the operating limit(s) for each boiler have not changed or provide documentation of revised operating limit(s) established. Additionally, the report shall include all applicable information required by 40 CFR 63.7550, Subpart DDDDD.

## SECTION 7. TITLE VI REQUIREMENTS

The following are applicable or potentially applicable requirements originating from Title VI of the Clean Air Act – Stratospheric Ozone Protection. The full text of the referenced regulations may be found on-line at <http://www.ecfr.gov/> under Title 40, or DEQ shall provide a copy upon request from the permittee.

- 7.1 If the permittee produces, transforms, destroys, imports or exports a controlled substance or imports or exports a controlled product, the permittee shall comply with the applicable requirements of 40 CFR Part 82, Subpart A – Production and Consumption Controls.
- 7.2 If the permittee performs service on a motor vehicle for consideration when this service involves the refrigerant in the motor vehicle air conditioner (MVAC), the permittee shall comply with the applicable requirements of 40 CFR Part 82, Subpart B – Servicing of Motor Vehicle Air Conditioners.
- 7.3 The permittee shall comply with the applicable requirements of 40 CFR Part 82, Subpart E – The Labeling of Products Using Ozone-Depleting Substances, for the following containers and products:
  - (a) All containers in which a class I or class II substance is stored or transported;
  - (b) All products containing a class I substance; and
  - (c) All products directly manufactured with a process that uses a class I substance, unless otherwise exempted by this subpart or, unless EPA determines for a particular product that there are no substitute products or manufacturing processes for such product that do not rely on the use of a class I substance, that reduce overall risk to human health and the environment, and that are currently or potentially available. If the EPA makes such a determination for a particular product, then the requirements of this subpart are effective for such product no later than January 1, 2015.
- 7.4 If the permittee performs any of the following activities, the permittee shall comply with the applicable requirements of 40 CFR Part 82, Subpart F – Recycling and Emissions Reduction:
  - (a) Servicing, maintaining, or repairing appliances containing class I, class II or non-exempt substitute refrigerants;
  - (b) Disposing of appliances, including small appliances and motor vehicle air conditioners; or
  - (c) Refrigerant reclaimers, technician certifying programs, appliance owners and operators, manufacturers of appliances, manufacturers of recycling and recovery equipment, approved recycling and recovery equipment testing organizations, as well as persons selling, offering for sale, and/or purchasing class I, class II, or non-exempt substitute refrigerants.

- 7.5 The permittee shall be allowed to switch from any ozone-depleting substance to any acceptable alternative that is listed in the Significant New Alternatives Policy (SNAP) program promulgated pursuant to 40 CFR Part 82, Subpart G – Significant New Alternatives Policy Program. The permittee shall also comply with any use conditions for the acceptable alternative substance.
- 7.6 If the permittee performs any of the following activities, the permittee shall comply with the applicable requirements of 40 CFR Part 82, Subpart H – Halon Emissions Reduction:
- (a) Any person testing, servicing, maintaining, repairing, or disposing of equipment that contains halons or using such equipment during technician training;
  - (b) Any person disposing of halons;
  - (c) Manufacturers of halon blends; or
  - (d) Organizations that employ technicians who service halon-containing equipment.
